Subject: Notice for Hearing on 27th October, 2015 (Tuesday) at 11:00 AM.

WHEREAS under Section 19 of the Right to Information Act, 2005, and in accordance to the Nagaland State Information Commission (Appeal Procedure) Rules, 2005, the Nagaland Information Commission had, on 23.06.2015 at 2:00 PM. heard the Second Appeal dated 24.05.2015 from Zeneisüle Ate Loucü, C 1/6, 2nd Floor, Sector -52, Ardee City, Gurgaon, Haryana – 122001, Mobile No. 91-8415068612, email: atEAU@hotmail.com, stating that in response to her RTI application dated 12.12.2014, the PIO, DRDA, Kohima, Nagaland had knowingly furnished incorrect, misleading and illegible documents and that in response to her subsequent first appeal dated 05.03.2015, the FAA had illegally, malafidely and contrary to the provisions of the RTI Act rejected her appeal merely on the ground that the applicant was not present during the hearing.

AND WHEREAS, the Commission had, after hearing the parties on 23.06.2015 at 2:00 PM., passed decision vide even No. dated **25.06.2015.**

AND WHEREAS, in compliance to the decision of the Commission dated 23.06.2015, Shri. Imlimeren Jamir, Joint Director, who represented the FAA had, vide letter No. DRD/ME/RTI/AA-5/2015-16/56 dated 14.08.2015 submitted a copy of the decision on the first appeal which was heard on 13.08.2015, stating that the information were furnished to the applicant(now appellant).

AND WHEREAS, on receipt of the information on 04.09.2015, the applicant(now appellant) had, vide letters dated 12.09.2015 and 21.09.2015 submitted to the Commission that she was not satisfied with the information so received, since the Muster Roll numbers were not readable, money was granted for construction of the hall and allied buildings but not spent to the Job Card Holders, and therefore given wrong and illegal documents (six pages were illegal) resulting in misleading information.

AND WHEREAS, the Commission has decided to hear the appeal again, giving opportunity to all the parties, on **27th October, 2015 (Tuesday) at 11:00 AM** in the **Hearing Room of the Nagaland Information Commission, Old Secretariat Complex, Kohima.**
