WHEREAS under Section 19 of the Right to Information Act, 2005, the Nagaland Information Commission had on 08.12.2014 received a second appeal dated NIL (in English) from Shri. Man Singh, H. No. 147, Village Kanipla Ki Taprian, P.O. Saravan, Tehsil: Bilaspur, Distt. Yamuna Nagar (Haryana), Mobile No. 09991149568, stating that he did not receive any information to his <u>first appeal dated 23.09.2014(in Hindi)</u> addressed to the DTO, Tuensang, Nagaland which was submitted against the non-reply of the D.T.O. Tuensang, Nagaland to his RTI application dated 04.08.2014.

AND WHEREAS, the applicant had earlier submitted an RTI application dated **04.08.2014** (in Hindi), which this Commission had translated into **English**. In the translated RTI application, the applicant had written to the PIO & DTO, Tuensang, Nagaland along with the prescribed application fee of Rs. 10/- (Rupees ten only) paid vide IPO No. 23F 681037 dated 25-07-2014, seeking the following information regarding Driving Licence No. 26603/TV/T/2010:-

- i. That above said DL is issued in the name of Gurmej Singh, S/O Satpal Singh, R/O Vill- Kanipla Ki Taprian, Tehsil: Bilaspur, Distt. Yamuna Nagar (HR) for M/cycle & LMV Dated 4-06-2010 by your office?
- ii. That above said DL is further endorsed for MGV/HMV/HTV/HGV/PSV on dated 28-09-2011 by Badge No. 8599 & also Renewed upto 2-06-2016? (Photocopy of DL enclosed)

AND WHEREAS, the applicant had also enclosed a photocopy of the above mentioned Driving Licence bearing No. 26603/TV/T/2010 issued to Gurmej Singh, S/O Satpal Singh, Vill- Kanipla Ki Taprian, Tehsil: Bilaspur, Distt. Yamuna Nagar (HR) and desired the **Certified copy of DL's Office record.**

AND WHEREAS, on not getting any information to his RTI application dated 04.08.2014 within the stipulated time frame of 30 days, the applicant had preferred <u>first</u> <u>appeal dated 23.09.2014(in Hindi)</u> addressed to the DTO, Tuensang, Nagaland. The First Appeal was also translated into English by this Commission.

AND WHEREAS, on not getting any information till date, the applicant (now appellant) had preferred a second appeal dated Nil before this Commission.

AND WHEREAS, since there was no information furnished or received till date even after filing of the first appeal, and there is no record of hearing of the first appeal, the Commission has decided to hear the appeal, giving opportunity to the parties, 28th April, 2015 (Tuesday) at 2:30 PM in the Hearing Room of the Nagaland Information Commission, Old Secretariat Complex, Kohima.
