


Subject: Notice for hearing on 26th July (Tuesday) at 1:00 PM.

WHEREAS under Section 19 of the Right to Information Act, 2005, the Nagaland Information Commission had on 30.10.2015 received a second appeal dated 30.10.2015 from Longri Ao, Camp: Kohima, Mobile No. 943600416, stating that there was no response from the First Appellate Authority, Department of Finance, Government of Nagaland, Nagaland, Kohima to his first appeal dated 31.08.2015 which was submitted against the non-furnishing of information to his RTI application dated 10.07.2015.

AND WHEREAS, the Commission had after hearing the appeal on 24.11.2015 at 1:00 PM passed decision dated 30.11.2015 and also after the Second hearing on: 04.02.2016 at 1:00 PM passed its Decision dated 06.02.2016.

AND WHEREAS, in compliance to the decisions of the Commission dated 06.02.2016, the OSD & PIO, Finance Department had furnished the information to query No. 1 vide letter No. FIN/REV-4/RTI/4/14 dated 18.02.2016; and to query Nos. 2, 3 and 4 vide letter No. FIN/REV-4/RTI/4/14/77 dated 21.04.2016.

AND WHEREAS, also in compliance to the decisions of the Commission dated 06.02.2016 the PIO had, vide letter No. FIN/REV/GEN/2/14/76 dated 22.04.2016 furnished query No. 5 regarding the list of staff in the office of the Principal Secretary & Finance Commissioner & FAA and the Secretary(Budget) when the RTI file and the first appeal were misplaced, as shown below:-

AND WHEREAS, in order to ascertain the satisfaction of the applicant(now appellant) with the information so received and also the issue regarding the missing of the RTI file, the Commission had, vide letter of even No. dated 02.06.2016 scheduled a hearing on 16th June (Thursday) at 12:00 PM.

AND WHEREAS, on the request of the PIO, vide letter No. FIN/REV-4/RTI/2/14/118 dated 13.06.2016 to re-schedule the date of hearing on account of attending a conference of State Finance Secretaries organised by the Reserve Bank of India at Mumbai on 17th June, 2016, the Commission had vide letter of even No. dated 14.06.2016 postponed the hearing to a later date.

AND WHEREAS, the Commission has now rescheduled the hearing on <u>26th July</u> (<u>Tuesday</u>) at 1:00 PM in the Hearing Room of the Nagaland Information Commission, Old Secretariat Complex, Kohima inorder to hear the appeal, giving opportunity to all the parties.
