Subject: Notice for Hearing on 8th December, 2015 (Tuesday) at 1:00 PM.

WHEREAS under Section 19 of the Right to Information Act, 2005, the Nagaland Information Commission had on 16.11.2015 received a second appeal dated 16.11.2015 from Medongulo Lomi, Ketoupa Colony, Pfutsero Town, District Phek, Nagaland – 797107, Mobile No. 9862582293/ 9089641859, stating that there was no response from the First Appellate Authority & Deputy Commissioner, Phek, District – Phek, Nagaland to his first appeal dated 09.10.2015 which was submitted against the non-furnishing of information by the PIO, Office of the Additional Deputy Commissioner, Pfutsero, Phek to his RTI application dated 28.07.2015.

AND WHEREAS, the above applicant had earlier submitted an RTI application dated **28.07.2015** addressed to the PIO, Office of the Additional Deputy Commissioner, Pfutsero, Phek alongwith the prescribed application fee of Rs. 10 (Rupees ten only) seeking the following:-

- i) *Whether the office of the ADC, Pfutsero received the draft No. QL/A/29/377464 dated 30/03/1991 as compensation from the department of Nagaland State Transport vide NST/B/11/90-91/101-03 dated 30/04/1991 for payment to the land owners of the acquired land at Ketoupa colony, Pfutsero Town by the Nagaland State Transport department.*
- ii) *If the above mentioned draft and amount was received, whether it was disbursed/given to the land owners of the above mentioned acquired land.*
- iii) *If the amount was disbursed to the land owners as compensation, kindly mention or furnish the names of owners that received compensation and amount received by them.*
- iv) *If the amount of compensation was not disbursed to the intended land owners, please furnish in what way or how the above amount/draft was utilised and their receipt too.*
- v) *If any documents pertaining to the said land acquired by the Nagaland State Transport at Ketoupa colony, Pfutsero, please furnish if any.*

AND WHEREAS, the RTI application dated 28.07.2015 was received by the Extra Assistant Commissioner Pfutsero, Phek on 29.07.2015 as evidenced on the body of the RTI application.

AND WHEREAS, on not getting any response to his RTI application dated 28.07.2015 from the PIO, Office of the Additional Deputy Commissioner, Pfutsero, Phek within the stipulated time frame of 30 days, the applicant had submitted a first appeal dated **09.10.2015** addressed to the Appellate Authority, Deputy Commissioner, Phek, District – Phek, Nagaland, and enclosing with a copy of his RTI application dated 28.07.2015.

AND WHEREAS, the first appeal dated 09.10.2015 was received by the Office Superintendent, Office of the Deputy Commissioner, Nagaland, Kohima on the same date i.e. 09.10.2015 as evidenced on the body of the first appeal.

AND WHEREAS, since there was neither any response to the RTI application 28.07.2015 nor to the first appeal dated 09.10.2015, the Commission has decided to hear the appeal, giving opportunity to all the parties on **8th December, 2015 (Tuesday) at 1:00 PM** in the **Hearing Room of the Nagaland Information Commission, Old Secretariat Complex, Kohima.**
