Subject: Notice for Hearing on 8th December, 2015 (Tuesday) at 12:00 PM.

WHEREAS under Section 19 of the Right to Information Act, 2005, a second appeal dated 11.08.2015 was filed by Dr. Devjee Mishra, Village – Jagatpur, P.O – Parashurampur, District – Bhojpur (Ara), Bihar – 802316, Mobile No. 9097710456 before the Central Information Commission, New Delhi against the non response of the First Appellate Authority, The Global Open University Nagaland, Sodzulhou Village, P.O – ARTC, NH-39, Dimapur, Nagaland - 797115 to his first appeal dated 30.06.2015, which was subsequently submitted against the non furnishing of information by the PIO, The Global Open University Nagaland to his RTI application dated 25.05.2015. The applicant had also, in his second appeal enclosed an IPO bearing No. 28F 557209 dated 29.06.2015 for Rs. 10 (Rupees ten only) in favour of the Central Information Commission, R. No. 326, C-Wing, II Floor, August Kranti Bhawan, Bhikaji Cama Place, New Delhi - 110068.

AND WHEREAS, the Nagaland Information Commission had on 16.11.2015 received the second appeal dated 11.08.2015 transferred by the Central Information Commission, New Delhi vide Diary No. 154275/2015 dated 03.11.2015 as it pertains to this Commission.

AND WHEREAS, the above applicant had earlier submitted an RTI application dated **25.05.2015** addressed to the PIO, The Global Open University Nagaland, Sodzulhou Village, P.O – ARTC, NH-39, Dimapur, Nagaland - 797115 alongwith the prescribed application fee of Rs. 10 (Rupees ten only) paid vide IPO No. 28F 534359 seeking the following information with regard to the student who passed Master of Philosophy (M. Phil) in Law with First Class whose Roll No. was **M. Phil/1725/JS/2008J**:-

- i. Name and complete address of the student;*
- ii. Certificate No. of M. Phil in Law;*
- iii. Attested copies of LLM Certificate and Mark Sheet of amitted to the M. Phil course.*
- iv. Venue of Examination/ Examination Schedule;*
- v. Cross List of all the students who appeared in M. Phil in Law Exam.*
- vi. Attested copies of the Answer Book of the Student.*

AND WHEREAS, on not getting any response to his RTI application dated 25.05.2015 from the PIO, The Global Open University Nagaland, Sodzulhou Village, P.O – ARTC, NH-39, Dimapur, Nagaland - 797115 within the stipulated time frame of 30 days, the applicant had submitted a first appeal dated 30.06.2015 addressed to the Appellate Officer, The Global Open University Nagaland, Sodzulhou Village, P.O – ARTC, NH-39, Dimapur,

Nagaland - 797115 alongwith a fee of Rs. 10 (Rupees ten only) paid vide IPO No. 28F 557203 dated 30.06.2015 and enclosing a copy of his RTI application dated 25.05.2015.
