Subject: Notice for Hearing on 20th January, 2016 (Wednesday) at 2:30 PM.

WHEREAS under Section 19 of the Right to Information Act, 2005, a second appeal vide No. S&A:UIIC/Appeal/RTI/II-III/2015 dated 29.11.2015 has been received on 14.12.2015 from Devinder Sharma, AIII, Investigator & Loss Assessor, Krishna Cottage, 27-D, Dayal Bagh, Ambala Cantt – 133001, Haryana stating that he did not get the information from the District Transport Officer & PIO, Wokha, Nagaland within the stipulated time frame and inspite of his two first appeals vide No. S&A:DL VERI:UIIC/CRO/RTI/2015 dated 23.09.2015 and 28.11.2015.

AND WHEREAS, the above applicant had earlier, sent by Speed Post bearing No. EH382201061IN dated 07.08.2015 the RTI application vide No. S&A:DL VERI:UIIC/CRO/RTI/2015 dated 07.08.2015 addressed to the PIO, District Transport Officer, District – Wokha, Nagaland alongwith an IPO No. 75G 196215 for Rs. 50/- (Rupees fifty only) towards the prescribed application fee and cost of information seeking the following information:-

- i. *Date of deposit of driving licence No. 81820/NW/NTV/09 dated 16.07.2009 fee with DTO, District Wokha, Nagaland and certified copy of its Receipt No. with amount.*
- ii. *Certified copy of driving test report of applicant, Mr. Jasmer, S/O Sh. Moti Ram, R/o Village- Gurusar PS, Sadar Narwan, Tehsil Narwana, District Jind, Haryana required before issue of DL (Professional) as per MV Act, 1988.*
- iii. *Certified copy of the applicant, Mr. Jasmer, S/O Sh. Moti Ram for issue of Driving Licence.*
- iv. *Complete driving licence No. 81820/NW/NTV/09 dated 16.07.2009 verification report.*

AND WHEREAS, the above applicant stated that the District Transport Officer & PIO, Wokha had received his RTI Application on **13.08.2015**, however, on not getting any response or information from the District Transport Officer & PIO, Wokha to his RTI application, he had sent by Speed Post bearing No. EP360076398IN dated 18.09.2015 a first appeal, vide letter No. S&A:DL VERI:UIIC/CRO/RTI/2015 dated 24.09.2015 addressed to the First Appellate Authority & Transport Commissioner, Transport & Motor Vehicles Department, Nagaland, Kohima – 797001.

AND WHEREAS, the First Appellate Authority & Transport Commissioner, Transport & Motor Vehicles Department, Nagaland, Kohima – 797001 had, vide letter No. TC/ESTT-RTI/APPEAL/302/2014(87)/1918-19 dated 28.10.2015 directed the District Transport Officer & PIO, Wokha to furnish the information to the applicant directly and under intimation to his office since there was no response till date.

AND WHEREAS, the DTO & PIO, Wokha had, vide letter No. DTO/NW/MV/10-11/05/279 dated 19.11.2015 wrote to the applicant (now appellant) and with a copy to the First Appellate Authority & Transport Commissioner, Transport & Motor Vehicles Department, Nagaland, Kohima, stating that the *driving licence No. 81820/NW/NTV/09 issued on 16.07.2009 in the name of Mr. Jasmer, S/O Sh. Moti Ram in the booklet/manual format by his office stand invalid as per Transport Commissioner's Order No. TC No. 23/MV/2007(PT-I) dated 01.08.2014 directing all DL holders to convert to Smart Card (Sarathi) format. Further, the DL will be validated only after the licence holder personally appears before the concerned office for conversion to Sarathi Driving Licence.*

AND WHEREAS, again, the applicant had sent by Speed Post bearing No. EH601558741IN dated 29.11.2015 another first appeal vide letter No. S&A:DL VERI:UIIC/CRO/RTI/2015 dated 28.11.2015 addressed to the First Appellate Authority & Transport Commissioner, Transport & Motor Vehicles Department, Nagaland, Kohima – 797001

stating that though direction was given to the District Transport Officer & PIO, Wokha, Nagaland to furnish the information, he had not received the information till date.

AND WHEREAS, on not getting the Driving Licence Verification Report of No. 81820/NW/NTV/09 issued on 16.07.2009 from the District Transport Officer & PIO, Wokha, Nagaland nor any response from the First Appellate Authority & Transport Commissioner, Transport & Motor Vehicles Department, Nagaland, Kohima – 797001 to his two first appeals, the applicant had preferred a second appeal vide No. S&A:UIIC/Appeal/RTI/II-III/2015 dated 29.11.2015 before this Commission.

AND WHEREAS, the Commission has decided to hear the appeal, giving opportunity to all the parties on **20th January, 2016 (Wednesday) at 2:30 PM** in the **Hearing Room of the Nagaland Information Commission, Old Secretariat Complex, Kohima.**

NOW THEREFORE, it is notified that the following concerned are directed to appear before this Commission and **also to bring the files and relevant documents** in question for scrutiny, on the above date and time for hearing.
