**Subject: Notice for Hearing on 22<sup>nd</sup> January, 2016 (Friday) at 12:30 PM.**

WHEREAS under Section 19 of the Right to Information Act, 2005, a second appeal dated 14.12.2015 has been received on 14.12.2015 from Shri. Vikheto Zhimomi, P.R Hill, Kohima, Mobile No. 9615115300, 9089896123, stating that in response to his first appeal dated 28.09.2015, the FAA & Chief Engineer, PWD (R&B), Nagaland, Kohima had furnished him incomplete information which was submitted against the non-response of the PIO, Office of the Chief Engineer, PWD (R&B), Nagaland, Kohima to his RTI Application dated 07.08.2015.

AND WHEREAS, the above applicant had earlier submitted an RTI application dated 07.08.2015 addressed to the PIO, Office of the Chief Engineer, PWD (R&B), Nagaland, Kohima alongwith the prescribed application fee of Rs. 10/- (Rupees ten only) paid in cash seeking the following information for public interest:-

- i. true copy of Sanction/Release Orders for 2013-14 Annual Plan.*
- ii. Work Orders for 2013-14 Annual Plan.*
- iii. All the Actual Payee Receipts (APRs) for 2013-14 Annual Plan.*
- iv. All completion certificates and also the name & designation of the officers who inspected the work allotted during 2013-14.*
- v. The amount kept in CD (Civil Deposit) from 2013-14 Annual Plan. If any, furnish photocopy of documents.*
- vi. Maintain all the ongoing/incomplete works allotted during 2013-14 Annual Plan.*
- vii. All the photocopy of Challan deposited in Government account for deduction in the form of various taxes during 2013-14 Annual Plan.*

AND WHEREAS, the above RTI application dated 07.08.2015 was received by the Public Authority on 11.08.2015 as evidenced on the body of the copy of the above RTI application.

AND WHEREAS, on receipt of the above RTI application dated 07.08.2015, Er. J. Talimeren Aier, Addl. Chief Engineer & PIO, Office of the Chief Engineer, PWD(R&B), Nagaland, Kohima had, vide letter No. CE(R&B)/TB/RTI/2011-12 dated **10.09.2015** requested the applicant for extension of time for furnishing of the information as the information sought had not reached his office from all the 23 (twenty three) Divisions under the PWD(R&B). Further, the PIO added that the required information would be furnished by the fourth week of September, 2015 positively.

AND WHEREAS, on not getting any information even after the fourth week of September, 2015 from the Addl. Chief Engineer & PIO, Office of the Chief Engineer, PWD(R&B), Nagaland, Kohima, the applicant had preferred first appeal dated 28.09.2015 before the Appellate Authority, Office of the Chief Engineer, PWD(R&B), Nagaland, Kohima. The First appeal dated 28.09.2015 was received on the same date i.e. 28.09.2015.

AND WHEREAS, Er. S. Zao, Chief Engineer & First Appellate Authority, PWD(R&B), Nagaland, Kohima had, vide letter No. CE(R&B)/TB/RTI/2015-16 dated **03.12.2015** furnished the information to the applicant (now appellant), except the information pertaining to Zunheboto Division as the information was yet to be received from the Zunheboto Division.

AND WHEREAS, on receipt of the information from the Office of the Chief Engineer, PWD(R&B), Nagaland, Kohima on 11.12.2015, the applicant (now appellant) had submitted a second appeal dated 14.12.2015 to this Commission stating that the information furnished to him was **incomplete**.

AND WHEREAS, the Commission has decided to hear the appeal, giving opportunity to all the parties on **22<sup>nd</sup> January, 2016 (Friday) at 12:30 PM** in the **Hearing Room of the Nagaland Information Commission, Old Secretariat Complex, Kohima.**
