WHEREAS under Section 19 of the Right to Information Act, 2005, a second appeal dated 10.11.2015 <u>in Hindi</u> has been received on 21.11.2015 from Anil Kumar Khare, S/o Narendra Khare, Village- Jhigaura, P.O – Kulua, Tehsil – Niwari, District – Tikamgarh, Madhya Pradesh – 472447, stating that there was no response to his first appeal which was submitted against the non-response to his RTI application dated 27.06.2015 submitted to The Global Open University Nagaland.

AND WHEREAS, the above applicant had earlier submitted an RTI application dated **27.06.2015** in **Hindi** addressed to the PIO, The Global Open University Nagaland alongwith the prescribed application fee of Rs. 10 (Rupees ten only) paid vide IPO No. 31F 864188 dated 27.06.2015 seeking the following information pertaining to Ravinder Kumar Yadav, S/O Sovaram Yadav, Village- Jhigaura, P.O – Kulua, Tehsil – Niwari, District - Tikamgarh, Madhya Pradesh whose Roll Number was DCA/330/2008D and had appeared exams in Diploma of Computer Applications in December 2009:-

- *i. Fee receipt number.*
- ii. Attendance Register copy of the student.
- iii. List of all the students in the register/attendance copy.
- *iv.* Admit Cards of students who sat for examination with the above said person in the same year.
- v. Answer scripts of the student.
- vi. Verification/genuineness of Diploma Mark sheet
- vii. Date of admission

AND WHEREAS, on not getting any response or information to his RTI application dated 27.06.2015, the applicant had submitted a first appeal presumably dated 16.07.2015 to the Appellate Authority. However, no evidence of the first appeal was found enclosed.

AND WHEREAS, further still, on not getting any response, the applicant had preferred a second appeal dated 10.11.2015 in Hindi before the Commission. Besides the second appeal dated 10.11.2015 in Hindi, the applicant(now appellant) had also enclosed a translated version of his second appeal dated 10.11.2015 in English, however, since it was poorly translated, it was not clearly understood.

AND WHEREAS, meanwhile, in response to the above RTI application dated 27.06.2015, Shri. Keluozie Kesiezie, PIO, The Global Open University Nagaland had, vide letter No. GOUK/ADMN/1-4/06/VOL XI/605 dated <u>30.11.2015</u> furnished the replies to the applicant.

AND WHEREAS, since the information was furnished to the applicant (now appellant) after the expiry of the 30 days time limit, the Commission had decided to hear the appeal, giving opportunity to all the parties, on  $22^{nd}$  January, 2016 (Friday) at 2:30 PM in the Hearing Room of the Nagaland Information Commission, Old Secretariat Complex, Kohima.
