

AND WHEREAS, the above applicant had earlier submitted an RTI application dated 01.11.2015 addressed to the PIO, The Global Open University Nagaland, alongwith the prescribed application fee of Rs. 10/- (Rupees ten only) paid vide IPO No. 31F 215939 dated 01.11.2015 seeking the following information:-

- b. Is The Global Open University/society/agency is involved in promoting/running any other university/institute if yes please give details?
- c. Pls. provide details all programmes permitted to be offered by gazette notification of state govt. & its reference?
- d. What is the sources of finance and quantum of funds available:-

From: Fees

From: State Govt.

From: UGC

From: other sources or (from sponsors)?

Please provide full details?

- e. What is corpus fund/endowment fund of the society/trust? Detail of all bank account statement year 2013-2014? Pan card no. of university/society on behalf of bank account opened? Please provide full details?
- f. Provide statement of income & expenditure for the last three year, year wise?
- g. Provide university land documents, name registered in the name of university and its location in the state? Deposit made in the name of society/university separately or jointly with state authority?
- h. Please provide details of administration office with mobile number and total plinth area of university, built areas, buildings areas details etc.?
- i. Provide detail number of classrooms & laboratories?
- j. Whether students already admitted? If yes, details of courses and the number of students admitted in each course during the last two year. How many Ph. D students are enrolled till Oct. 2015?
- k. Whether university has any off-campus or study center or admission center established outside the state/abroad?
- l. What is the admission procedure of university?
- m. What is the fee structure for different courses run by the university with details?
- n. How many sanctioned post of professors, readers and lectures?
- o. What is the Name, designation, qualifications & publication of the existing teaching staff (department wise). Please provide full details?
- p. Whether institute is following UGC pay scale for teaching staff?

AND WHEREAS, the applicant had given his address as 1133/14B, Luxmi St. Shivpuri Road, Ludhiana-141001, Punjab in his RTI application dated 01.11.2015 which was sent to the public authority by Speed Post vide No. RP496078190IN dated 02.11.2015.

AND WHEREAS, on not getting any response to his RTI application dated 01.11.2015 from the PIO, The Global Open University Nagaland within the stipulated time, the applicant had preferred a first appeal dated 15.12.2015 to the Appellate Authority, The Global Open University Nagaland. The first appeal was sent to the public authority vide Speed Post No. RP488892460IN on 17.12.2015.
