The Commission in its decision on 25.11.2009 had directed Shri Ezanimo Lotha PIO of Nagaland Khadi and Village Industries Board, Kohima to show cause as to why he should not pay penalty at the rate of Rs. 250.00 for each day of delay, subject to a maximum of Rs. 25,000.00 for delay in furnishing information sought for 88 days from 13.2.2009 to 13.5.2009, within 10 days.

Shri Ezanimo Lotha PIO submitted his reply to show cause on 4.12.2009, stating that the RTI application of 5.1.2009 received on 12.1.2009 had sought information for 20 years which he had tried to search out and that he had vide his letter dated 22.1.2009 replied to Shri Khohoto regarding the information of total amount sanctioned for various KVIC Schemes and project w.e.f. 1988, requesting him to visit the Nagaland Khadi and Village Industries Board Office. He stated that Mr. Khohoto visited their Office only on 25.5.2009 and that he had furnished all the necessary documents within the required period, hence imposing penalty on the ground of non replying does not arise. He therefore requested for review of the show cause for imposing penalty, pleading lack of knowledge of RTI on his part and submitted that he may be exempted from paying penalty for delay in furnishing information from 13.2.2009 to 13.5.2009 as this is the first time for such lapse.

The Commission find that the submissions are not convincing nor reasonable cause for delay in furnishing the information sought. Information sought in RTI application received on 12.1.2009 was to be furnished within 30 days, by 12.2.2009 and penalty is imposeable for delay w.e.f. 13.2.2009. PIO's letter of reply shown dated 22.1.2009 was given to the applicant on 13.5.2009 only, as stated during hearing and the receipt record submitted by the appellant. Hence whatever information was given, however incomplete, was given to the applicant on 13.5.2009, 88 days after expiry of prescribed 30 days. No reason has been given for delay in giving the letter dated 22.12.2009 with information therein. Writing the reply on 22.1.2009 and keeping without giving the same to the applicant till 13.5.2009 does not mean that the information was given on 22.1.2009.

The Commission therefore decides to impose penalty under section 20 of the RTI Act 2005 on Shri Ezanimo Lotha, PIO of the NKVIB, Kohima for delay in furnishing information without reasonable cause for 88 days w.e.f. 13.2.2009 to 12.5.2009 at Rs. 250/- for each day of delay amounting to Rs. 22,000.00 (Rupees twenty two thousand)

He is directed to pay the amount by depositing it in the Government Treasury through Treasury Challan in favour of
