## **Facts**

The Commission received a complaint under section 18 (c) of the RTI Act 2005 from Shri Vimhaseo Richa C/o Kohima Law College on 8.12.2009 stating that he had submitted RTI application on 21.10.2009 addressed to the PIO, Directorate of Health & Family Welfare, Nagaland, Kohima seeking 4 items of information but the PIO has not given the information till date.

The PIO Shri R.F Lotha stated that the said RTI application was not given to him but the receipt signature dated 21.10.2009 on the photocopy of the application indicates that the same was received by the NRHM Section. He informed that the previous Officer dealing with NHRM who was the PIO, was no longer holding that post which does not exist, hence he as PIO of the whole Directorate is acting as PIO for NRHM. He was not aware that the RTI application was with the NRHM section till date.

The complainant was absent.

## **DECISION**

The Commission note that the information sought have not been given. A photocopy of the RTI Application dated 21.10.2009, as received by the NRHM section, is given to the PIO Shri R.F. Lotha today by the Commission. The prescribed 30 days expired on 21.11.2009.

The Commission direct the PIO to furnish the information sought to the applicant, free of cost, within 10 days from the date of pronouncement of this decision.

There has been delay in furnishing the information since 22.11.2009. Under Section 20 of the RTI Act 2005, a penalty at the rate of Rs. 250/- for each day of delay is imposeable on the PIO, subject to a maximum of Rs. 25,000/- for delay in furnishing information without reasonable cause.

The Commission direct the PIO Shri R.F. Lotha to show cause as to why he should not pay penalty at Rs. 250/- for each day of delay subject to maximum of Rs. 25,000.00, for delay in furnishing information w.e.f. 22.11.2009 till the date the information is given, within 10 days from the date of pronouncement of this decision.
