Facts

The Commission received a complaint under Section 18 (1) (c) of the RTI Act 2005 from Shri. Monjit Narayan Konwar, Rupnagar, Guwahati on 21.9.2010 stating that he had submitted RTI application dated 26.3.2010 to the District Transport Officer, Dimapur Nagaland (by Post) seeking information about driving license of Shri Biju Phukan Rabha, but that he had not been furnished the information till date, hence he was submitting complaint to the commission.

The complainant was not present during the hearing today. The PIO Cum District Transport Officer Dimapur submitted a letter dt. 12.10.2010 expressing inability to appear in person due to her physical condition medical ground but submitted that she had not received any such RTI application seeking information pertaining to driving license from Shri. Monjit Narayan Konwar, Rupnagar,. However on hearing from the commission, the PIO Cum District Transport Officer, Dimapur informed the Commission about details of the information sought, through an official of their office. Going by the records submitted to the Commission, the RTI application of Shri. M.N. Konwar dt. 26.3.2010 is shown to have been sent by Post on 27.3.2010, but no document to prove receipt by the addressee PIO Cum DTO Dimapur has been produced. The PIO Cum DTO, Dimapur vide her letter dt.12.10.2010 addressed to the Commission has given the details of the information sought.

Decision

The Commission direct the PIO Cum District Transport Officer, Dimapur to furnish the information sought by Shri. M.N. Konwar in his RTI application of 26.3.2010 (photocopy enclosed) to the applicant within 10 (Ten) days from the date of pronouncement of this order, under intimation to the Commission.

The PIO Cum District Transport Officer, Dimapur is directed to publicize the proper address of the office of the District Transport Officer Dimapur, Nagaland and furnish one copy to the Commission.
