The Commission in its decisi	ion dated 12.1.2011 directed Shri K.T. Thomas PIO and Joi	

The Commission in its decision dated 12.1.2011 directed Shri. K.T. Thomas PIO and Joint Director, Tourism, Nagaland to show cause as to why he should not pay penalty at the rate of Rs. 250/- per each day of delay, subject to maximum of Rs. 25.000.00 from 19.11.2010 to the date on which the information sought is furnished, within 10 days from the date of pronouncement of the decision on 12.1.2011.

Shri. K.T. Thomas PIO has accordingly submitted his reply to show cause on 19.1.2011, in which he submitted that the RTI application was received on 18.10.2010, due to preoccupation of the Department for Hornbill Festival (December 1-7, 2010), and Agri Expo thereafter and crash of hard disc of computer, the information sought could not be submitted and could be sent by registered post on 13.1.2011 only. He submitted that the delay was out of ignorance of the RTI provisions and requested that penalty may kindly not be imposed.

The Commission find that the reasons given in reply to show cause are not convincing as the information sought on 18.10.2010 could have been given much before Hornbill Festival, Agri Expo of December 2010.

## **Decision**

The Commission therefore decides to impose penalty on Shri. K.T. Thomas, PIO under section 20 of the RTI Act 2005, at Rs. 250/- per each day of delay from 19.11.2010 to 11.1.2011-54 days amounting to Rs. 13,500.00 for delay in furnishing information without reasonable cause.

He is directed to pay the amount by depositing it in the Government Treasury through Treasury Challan in favour of
