The Commission in its Decision Notice dated 12.9..2007 had directed the PIO to appear in person on 19.9.2007  
to-

1. Confirm the furnishing of information to the applicant as directed by the Commission
2. Inform the Commission whether mechanism as been set up and office sensitized to deal with RTI applications.

The PIO Shri K.J. Lohe, along with the 2 PIOs of Education Directorate appeared before the Commission on 19.9.2007 and reported that the information sought i.e. that there was no instruction from higher authorities for deduction of 50% from SSA funds provided to VEC for construction of School Buildings had been furnished and received by the applicant on 18.9.2007. He also stated that the RTI application of Shri Chubatangit Jamir was received by him from Shri Nukshilepba on 19.6.2007.

There was no confirmation that Mechanism has been set up or office sensitised except that PIOs had been designated.

The Commission find that there has been a delay of 62 days i.e. from 19.7.2007 to 18.9.2007 in furnishing the information to the applicant.

As per Section 20 (1) of the RTI Act 2005, a penalty at the rate of Rs. 250/- per each day of delay, subject to a maximum of Rs. 25,000/- is to be imposed on the PIO for failure to furnish information within the prescribed period of 30 days.

The PIO Shri K.J. Lohe is directed to appear in person before the Commission at 1130 hours on 24.10.2007 (Wednesday) to show cause as to why he should not pay penalty at the rate of Rs. 250/- for each day of delay for 62 days subject to maximum of Rs. 25,000.00.
