WHEREAS under Section 18(1)(b)(c) and Section 7(2) of the Right to Information Act, 2005, the Nagaland Information Commission have received a complaint dated 25.06.2012 from a complainant, Mr. Kusap, Chairman on behalf of Old Nkio Village Council, Peren district, Nagaland against the non-receipt of information from the PIO, Urban Development Department, Nagaland, Kohima to their RTI application dated 14.03.2012 even after the expiry of the 30 days time limit;

AND WHEREAS the PIO, Urban Development Department, Nagaland, Kohima re-directed the RTI application alongwith the fee to the Director, Urban Development, Nagaland, Kohima on 28.03.2012;

AND WHEREAS the Director, Urban Development, Nagaland, Kohima re-directed the matter to the Secretary, Urban Development Department, Nagaland, Kohima on 30.03.2012, stating that the requested by the Old Nkio Village Council, Peren district regarding declaration/establishment of new township in Nagaland is not within the purview of the department and that the matter be re-directed to the concerned department;

AND WHEREAS the RTI application was re-directed to the Secretary, Home Department on 10.04.2012. However, on 14.05.2012, the PIO, Home Department had returned the RTI application alongwith the fees to the Urban Development on the grounds that the Home department deals only with Village Councils and not with New townships;

AND WHEREAS on 31.05.2012, the Urban Development re-directed the application to the Home Commissioner, Nagaland, stating that the notification of townships is the subject matter of the Home Department and that the Urban Development deals only with the preparation of Master Plans;

AND WHEREAS the Nagaland Information Commission has decided to hear the complaint, giving opportunity to the parties on 9th August, 2012 (Thursday) 01:00 PM in the Hearing Room of the Nagaland Information Commission, Old Secretariat Complex, Kohima.
