**Subject: Order for closing of complaint case.**

WHEREAS under Section 18 of the Right to Information Act, 2005, and in accordance to the Nagaland State Information Commission (Appeal Procedure) Rules, 2005, the Nagaland Information Commission had, on 05.11.2014 at 12:00 PM. heard the complaint dated 26.08.2014 submitted by an applicant, Shri. Milap Singh, Ratouli Road Hunde Wala Farm House, Jagadhri – 135003, District Yamuna Nagar, Haryana stating that he did not receive any information or response to his RTI application dated 19.05.2014.

AND WHEREAS, the Commission had, after hearing the parties on 05.11.2014 at 12:00 PM, passed decision vide even No. dated **10.11.2014.**

AND WHEREAS, in compliance to the above decision of the Commission dated 10.11.2014, Smti. Thangkhonei Singsit, Addl. Secretary & APIO, Home Department, Police 'B' Branch, Nagaland, Kohima had vide letter No. POL/ARMS/6/2009 dated **12.11.2014** submitted that the same information had been sent again to the applicant(now complainant) by Speed Post bearing No. RE429901506IN dated 13.11.2014. A copy of the Speed Post receipt was also enclosed.

AND WHEREAS, the Commission had observed that since compliance to the decision of the Commission dated 10.11.2014 have been received from Smti. Thangkhonei Singsit, Addl. Secretary & APIO, Home Department, Police 'B' Branch, Nagaland, Kohima, and that sufficient time had lapsed, there was no complaint received from the applicant(now complainant), suggesting that the applicant was satisfied with the information so provided and that the applicant had no interest to pursue the case further, the Commission had decided to declare the **Complaint case closed.**
