**Subject: Order for closing of complaint case.**

WHEREAS under Section 18 of the Right to Information Act, 2005, and in accordance to the Nagaland State Information Commission (Appeal Procedure) Rules, 2005, the Nagaland Information Commission had, on 11.02.2015 at 11:00 AM. heard the complaint dated 19.09.2014, submitted by an applicant, Shri. L. Chubaonen, District Soil Conservation Officer, Mon, Nagaland, Mobile No. 9436403388 against the non-satisfaction with the information provided by the Deputy Secretary & PIO, Nagaland Public Service Commission (NPSC), Nagaland, Kohima to his RTI application dated 16.04.2014.

AND WHEREAS, the Commission had, after hearing the parties on 11.02.2015 at 11:00 AM., passed decision vide even No. dated **21.02.2015.**

AND WHEREAS, in compliance to the above decision of the Commission dated 21.02.2015, Shri. Kelhouseto Nakhro, Deputy Secretary & PIO, NPSC, Nagaland, Kohima had submitted that a Committee was constituted vide Notification No. NPSC/RTI Act, 2005 dated 17.02.2015 to search the following documents:-

- i. File No. NPSC/C-4/87;
- ii. Any Information relating to the conduct of Examination/Interview in respect of Assistant Soil Survey Officer (ASSO) against the Advertisement No. 4/86-87; and
- iii. Any correspondence relating to the nomination of Shri. Lipokmar Yaden against the post of ASSO in 1987.

AND WHEREAS, the above Committee had submitted it's report dated 25.02.2015 stating that:-

- i. after checking all the files, both current as well as the closed files available within the premises of the NPSC Office, the File No. NPSC/C-4/87 could not be traced.
- ii. as far as information relating to the said examination, the Committee could find only a letter NPSC/C-5/86 dated 15.11.1986 recommending the names of four (4) candidates for the posts of ASSO. And a photocopy of the letter was also enclosed.
- iii. as far as correspondence relating to the nomination of Shri. Lipokmar Yaden against the post of ASSO during 1987, the Committee could not find any document or letter.

AND WHEREAS, in compliance to the above decision of the Commission dated 21.02.2015, Shri. Kelhouseto Nakhro, Deputy Secretary & PIO, NPSC, Nagaland, Kohima had, vide No. NPSC/C-5/2011 dated 03.03.2015 submitted the following documents to this Commission and with a copy to the applicant(now complainant):-

- i. Committee Report dated 25.02.2015 pertaining to the search of documents/file pertaining to the recommendation of Shri. Lipokmar Yaden as Assistant Soil Survey Officer (ASSO) during 1987.
- ii. Letter No. NPSC/C-5/86 dated 15.11.1986 pertaining to the recommendation of four (4) candidates for the post of ASSO in 1986.
- iii. An **Affidavit** declaring that the file No. NPSC/C-4/87 could not be traced out.

AND WHEREAS, the Commission had observed that since compliance to the decision of the Commission dated 21.02.2015 have been received from Shri. Kelhouseto Nakhro, Deputy Secretary & PIO, NPSC, Nagaland, Kohima including the **Affidavit** declaring that the file No. NPSC/C-4/87 could not be traced out, the Commission had decided to declare the **Complaint case closed.**
