Subject: Order for closing of Complaint case.

WHEREAS under Section 18 of the Right to Information Act, 2005, and in accordance to the Nagaland State Information Commission (Appeal Procedure) Rules, 2005, the Nagaland Information Commission had, in four(4) hearings held on (i) 23.03.2015 at 2:30 PM, (ii) 08.04.2015 at 2:30 PM, (iii) 12.05.2015 at 2:30 PM and (iv) 15.07.2015 at 1:30 PM. heard the complaint dated 20.10.2014 submitted by an applicant, Shri. Yanrenthung Kikon, UDA, Judicial Section, Deputy Commissioner's Office, Wokha, Nagaland, Mobile No. 9856538858, 8974146911 against the non furnishing of information by the PIO, Office of the Irrigation & Flood Control, Wokha, Nagaland to his RTI application dated 11.08.2014 within the specified time limit under RTI Act, 2005.

AND WHEREAS, the Commission had, after hearing the complaint on 23.03.2015 at 2:30 PM passed its Interim Decision dated 24.03.2015, second hearing on 08.04.2015 at 2:30 PM. and passed its Interim Decision dated 13.04.2015, third hearing on 12.05.2015 at 2:30 PM. and passed its Interim Decision dated 13.05.2015 and fourth hearing on 15.07.2015 at 1:30 PM. and passed its Decision dated 27.07.2015.

AND WHEREAS, the Commission had, after the fourth and last hearing held on 15.07.2015 at 1:30 PM. passed decision vide even No. dated **27.07.2015**, wherein Er. Roland Jami, former Executive Engineer & PIO, Office of the Executive Engineer, Irrigation & Flood Control, Wokha, Nagaland and now presently posted as the Executive Engineer, Office of the Chief Engineer, Irrigation & Flood Control, Nagaland, Kohima was directed to produce the evidence of giving the information to the applicant (now complainant) on **28.08.2014** within **one (1) week** to the Commission.

AND WHEREAS, in compliance to the above decision of the Commission dated 27.07.2015, Er. Roland Jami had, vide letter dated Nil, which was received by the Commission on 27.07.2015, submitted the receipt or evidence of furnishing the information to the applicant on 28.08.2014 alongwith the 'List of applicants for projects under AIBP 2014-15 under Wokha district'. And while submitting the above compliance, Er. Roland Jami stated that since the applicant had asked **verbally** for the Compile List of applicants for 2014-15, which pertained to his the tenure, he had on his own volition furnished accordingly to the applicant on 28.08.2014.

AND WHEREAS, on examination of the documents, the Commission had observed that the receipt or evidence of furnishing the information to the applicant on 28.08.2014 alongwith the 'List of applicants for projects under AIBP 2014-15 under Wokha district' submitted was for the period from **2014-15** and not for **2009-2013** which the applicant had asked in his RTI application dated 11.08.2014, and hence, the Commission had, vide letter of even No. dated 01.08.2015 directed Er. Roland Jami, to submit the information/documents pertaining to the period from **2009-2013** which the applicant had asked in his RTI application dated 11.08.2014 and as per the decision of the Commission dated 27.07.2015, within **one (1) week** from the date of receipt of the directive.

AND WHEREAS, in compliance to the above directive of the Commission dated 01.08.2015, Er. Roland Jami had, vide letter dated 13.08.2015, submitted for **query No. 1**, a **receipt** from the applicant for receiving the information regarding details of M.I. Projects from **2009-2013** alongwith the copies of the information so furnished. Also, for **Query No. 2**, regarding DPR of M.I. Projects from 2009-2010, a '**Clarification**' was submitted wherein the applicant declared that he had decided not take /make Xerox copy of the DPR as it would involve high cost of making Xerox copies.

AND WHEREAS, the Commission had accepted and was satisfied with the above compliances to its decisions and subsequent directives, and also that since the applicant (now

complainant) had submitted to the Commission dated 15.07.2015 that he would abide by whatever the Commission decide in the matter, the Commission decided to declare the complaint case as closed.

NOW THEREFORE, it is notified to all the following parties that the complaint case is hereby declared as **closed**.
