

Subject: Notice for hearing on 5<sup>th</sup> November, 2014 (Wednesday) at 12:00 PM.

WHEREAS under Section 18 of the Right to Information Act, 2005, the Nagaland Information Commission had received a Complaint dated 26.08.2014, from an applicant, Shri. Milap Singh, Ratouli Road Hunde Wala Farm House, Jagadhri – 135003, District Yamuna Nagar, Haryana, stating that he did not receive any information or response to his RTI application dated 19.05.2014.

AND WHEREAS, earlier the applicant had, submitted an RTI application dated 19.05.2014, addressed to the PIO-cum-Chief Secretary, Government of Nagaland, Kohima, alongwith a fee of Rs. 50/- paid vide IPO No. 80G 478785 and another IPO No. 09B 529805 for Rs. 2.00 requesting for information regarding individual Arm Licence on the following points:-

- 1. Whether the Notification of 8<sup>th</sup> August, 1987 whereby the Licensing Authority for the weapons as covered under Section 1B and 1C of Schedule I under Rule 3 of the Arms Rules, 1962 of the Central Government still holds good?
- 2. Whether the State Government has the authority to make licencee under Section 1B and 1C of Schedule I under Rule 3 of the Arms Rules, 1962?
- 3. Whether after the judgment passed in the case of the State of Punjab versus Swaran Singh in murder reference No. 5 of 2000 passed by the Hon'ble Full Bench of Punjab and Haryana High Court, Chandigarh on 26.05.2009 and the order passed in the case titled Subash Ram Kumar Bind @ Vakil and another versus State of Maharashtra, 2003 (1) RCR(Crl) (709), the weapon cover under Section 1B and 1C of Schedule I under Rule 3 of the Arms Rules, 1962 are still the prohibited weapon?

AND WHEREAS, on receipt of the above RTI application dated 19.05.2014, Ningsang Tally, OSD to Chief Secretary, Government of Nagaland, Kohima had, vide letter No. CSO/10/RTI/2014 dated 29.05.2014 forwarded the above RTI application dated 19.05.2014 in original alongwith the two (2) above mentioned IPOs for a total amount of Rs. 52.00 to the Special Secretary, Home Department, Government of Nagaland, Kohima, stating that the information is not available in the Office of the Chief Secretary, Government of Nagaland, Kohima and had requested to furnish the information directly to the applicant. A copy to the said letter was also endorsed to the applicant.

AND WHEREAS, since there was no reply to the above RTI application dated 19.05.2014 from the Special Secretary, Home Department, Government of Nagaland, Kohima till date, the applicant(now complainant) had submitted a complaint dated 26.08.2014 before this Commission.

AND WHEREAS, the Commission has decided to hear the complaint, giving opportunity to the parties, on 5<sup>th</sup> November, 2014 (Wednesday) at 12:00 PM in the Hearing Room of the Nagaland Information Commission, Old Secretariat Complex, Kohima.
