Subject: Order for closing of Complaint case.

WHEREAS under Section 18 of the Right to Information Act, 2005, and in accordance to the Nagaland State Information Commission (Appeal procedure) Rules, 2005, the Nagaland Information Commission had heard the complaint submitted by Shri. H. Sema and Shri. L. Lotha, C. L. Law & Associates, Lotha Hoho Ki, DC Court Junction, Dimapur, Nagaland, Mobile No. 9436267648 on four occasions i.e. 26.04.2016 at 2:00 P.M, 25.10.2016 at 11:00 A.M, 07.09.2017 at 12:30 P.M and 30.10.2017 at 1:00 P.M.

AND WHEREAS, the Commission had, after the fourth hearing on 30.10.2017 at 1:00 P.M passed its decision vide even no. dated 20.11.2017 wherein penalty was imposed on Shri. Sentiyanger Pongen, Under Secretary & former PIO (and now APIO), Municipal Affairs Department, Nagaland Civil Secretariat, Nagaland, Kohima for 54 days of delay @ ` 250.00 per day amounting to ` 13,500.00 (Rupees thirteen thousand five hundred only) for contributing to the delay in furnishing the information to the applicants (now complainants).

AND WHEREAS, in compliance to the decision of the Commission of even No. dated 20.11.2017, Shri. Sentiyanger Pongen, Under Secretary & former PIO (and now APIO), Municipal Affairs Department, Nagaland Civil Secretariat, Nagaland, Kohima had deposited the penalty amount of ` 13,500.00 (Rupees thirteen thousand five hundred only) vide Treasury Challan No. 5516 dated 21.12.2017.

AND WHEREAS, since the above Treasury Challan has been received, the Commission has decided to close this complaint case.

NOW THEREFORE, it is notified to all the parties that the complaint case is hereby declared as **closed.**
