WHEREAS under Section 18 of the Right to Information Act, 2005, and in accordance to the Nagaland State Information Commission (Appeal Procedure) Rules, 2005, the Nagaland Information Commission had, on 29.04.2015 at 12:00 PM. heard the complaint dated **30.03.2015**, submitted by an applicant, Mr. Neisazo Dzüvichü, Mobile No. 9774967734, against his non-satisfaction of the information furnished by the Kohima College, Kohima to the two(2) RTI applications dated 17.02.2015 and 20.02.2015.

AND WHEREAS, the Commission had, after hearing the parties on 29.04.2015 at 12:00 PM, passed decision vide even No. dated **05.05.2015**.

AND WHEREAS, in compliance to the above decision of the Commission dated 05.05.2015, Smti. Chubatola Longkumer, Principal & PIO, Kohima College, Kohima, Nagaland had, vide letter No. KCK/ADMN/2007/74 dated 05.05.2015 forwarded a copy of the Action Taken Report wherein the following three (3) Grade-IV staffs had been placed under suspension with immediate effect vide Order No. HED/ADMN-B-(c)2/2012 dated 30.04.2015 issued by the Director, Higher Education for the illegal disposal of answer scripts without permission and without the knowledge of the College authority:-
