Subject: Closing Order of Complaint case.

WHEREAS under Section 18 of the Right to Information Act, 2005, and in accordance to the Nagaland State Information Commission (Appeal Procedure) Rules, 2005, the Nagaland Information Commission had, on 06.11.2015 at 1:00 PM. heard the complaint dated NIL submitted by Mr. Vijay Hansaria, 422, New Lawyers' Chamber, Supreme Court, New Delhi – 110 001, Phone No. 011-23386970, Mobile No. 9810004042, email: hansari@gmail.com stating that the PIO had denied/refused his RTI application dated 11.06.2015 and had returned the application on 13.07.2015, with an endorsement showing “**Refused**” on the envelope.

AND WHEREAS, the Commission had, after hearing the complaint on 06.11.2015 at 1:00 PM. passed decision vide even No. dated 09.11.2015.

AND WHEREAS, in compliance to the decision of the Commission dated 09.11.2015, Shri. Ngamjok Konyak, Additional Secretary & PIO, Department of Law and Justice, Nagaland, Kohima had, vide letter No. LAW/RTI/37/2015 dated 16.12.2015, furnished the information to the applicant (now complainant) and had also submitted the report of the internal inquiry committee to this Commission.

AND WHEREAS, the Commission had, vide letter of even No. dated 21.12.2015 directed the PIO to confirm from the applicant (now complainant) regarding his satisfaction or any comments on the information so furnished to him, and inform the Commission **on or before 31.01.2016.**

AND WHEREAS, since the Commission had not received any response from the PIO, the Commission had again, vide letter of even No. dated 29.02.2016 reminded the PIO to inform the Commission within a **week's time**, whether any letter had been written to the applicant as directed by the Commission.

AND WHEREAS, in compliance to the directive of the Commission dated 29.02.2016, Shri. Ngamjok Konyak, Additional Secretary & PIO, Department of Law and Justice, Nagaland, Kohima had, vide letter No. LAW/RTI/32/2015 dated 03.03.2016, submitted to the Commission that the information had been furnished to the applicant (now complainant) and that the applicant had expressed satisfaction with the information so furnished.

AND WHEREAS, since the compliances have been received from the PIO and that the applicant (now complainant) had also expressed satisfaction with the information so furnished to him, the Commission had decided to close the complaint case.
