Subject: Notice for Hearing on 21st April, 2016 (Thursday) at 11:00 AM.

WHEREAS under Section 18 of the Right to Information Act, 2005, the Nagaland Information Commission had, on 02.03.2016 received a complaint dated 02.03.2016 from I. Chubatangit Jamir, Social Activist Nagaland, Near Office of the Commissioner of Taxes, Dimapur, House No. 252, Mobile No. 9436073062, 9615661525 stating that he did not receive any information from the PIO, Public Health Engineering Department, Nagaland, Kohima to his RTI application dated 24.11.2015 within the stipulated time.

AND WHEREAS, the above applicant had earlier submitted an RTI application dated 24.11.2015 addressed to the PIO, Public Health Engineering Department, Nagaland, Kohima, alongwith the prescribed application fee of Rs. 10/- (Rupees ten only) paid in cash seeking the following information:-

- (1) *Kindly furnish me the Administrative approval and expenditure sanction, for the Schemes included in the works programme from 2009 to till date under NRDWP and state plan in details breakup in district/village wise in Nagaland along with supportive documents of release order/sanction order in district wise and actual payment receipt by the department and actual payment made to each firms/civil work contractors and materials suppliers contractors from 2009 to till date.*
- (2) *Under Urban water supply programme to secretariat complex under state plan to provide drinking water supply in the area with an estimated cost of Rs.249.00 lakhs during 2012-14.*

How many fund has been released by the Government of Nagaland and how is the work was done?

Kindly furnish me in details along with utilization certificate and tender supporting documents of the contractors/Firms name.
- (3) *Kindly furnish me the details about the water metering system to Dimapur town under 11th Plan period which is a estimated cost of Rs.1654.54 lakhs from 2011. Please provide me the photo copies of released order/sanction order about the project and actual payment receipt by the department and actual payment made to the firm/contractor by the departments from 2011-till date.*
- (4) *Under Nirmal Bharat Abhiyan (NBA) the Govt. of India Funded Programme for rural areas doing away with the age old habit of open defecation and personal hygienic through conducts of mass awareness campaign and by construction of low cost sanitary toilets for individual households latrines (IHHL) Schools, Anganwadi centre and community complexes which the fund is directly transferred to the savings accounts of the SWSM and implementation of the programme is done by the District water sanitation mission (DWSM). Kindly furnish me the photo copies of Fund released by the Govt. of India and the Stat Govt. from 2009 to till date along with the supportive documents of released order/sanction orders of each works under taken till date in district wise and actual payment receipt/payment made to the Firm/contractor/village from 2009 to till date with No Objection Certificate from the concern location Authority where the work is under taken by the department.*
- (5) *Under National River Conservation plan (NRCP) the project pollution abatement of rivers Diphu and Dhansiri at Dimapur was sanctioned during 2005 with an estimated cost of Rs.7159.00 lakhs, the Govt. of India has released 450.00 lakhs and Rs.833.77 lakhs by the state Govt. of Nagaland as a state share.*

Kindly provide me in details about the project under taken by the department and actual payment made to the contractors/firms till date.
- (6) *A new scheme namely Aug. W/S through stream water source in Japukong Range at Mokokchung district under North East Council (NEC) please obtain me the actual money sanction and receipt from NEC and Govt. of Nagaland till date.*

Please give me the reasons along with the supportive document as to what kinds of developments has been done by the department indicating the names of the firms/contractor to whom the work was allotted with utilization certificate.

(7) Under the NLCPR Project, the PHED has taken up four projects out of which 2 (two) Nos. of project viz. Chen EAC Hq. and Chenwetnyu Village at Mon district with a sanction cost of Rs.279.48 lakh and prov. W/S to 24 villages of Chiebhobozou RD Block, Kohima district with a sanction of Rs.2626.41 lakhs are anticipated for completion within 2013-14.

The remaining 2 (two) sanctioned project viz. Aug of W/S to Wokha Town and prov. W/S to New Peren district Hq. with a sanctioned cost of Rs.1959.60 Lakhs and Rs.930.94 lakhs are likely to be spilled over to 2014-2015.

Please obtain me the details of the works under taken by the department along with the tender documents to whom the work was allotted with actual payment receipt and actual payment made to the Firm/Contractors till date.

(8) Twin lake conservation at Mokokchung town has been sanction during 2009-2010 with an estimated cost of Rs.2583.25 lakhs under National lake conservation plan (NLCP) the Govt. of India has released Rs.881.00 lakhs during 2013-2014 and the State Govt. of Nagaland has released Rs.123.00 lakhs as a state share.

Kindly give me the photo-copies of release order/sanction order and actual payment receipt and actual payment made to the Firm/contractor by the department till date along with the tender documents.

AND WHEREAS, the above applicant had given his address as Former Congress (I) Candidate from 21st A/C Tuli, District Mokokchung in his RTI application, and had also endorsed his RTI application to this Commission and to the Commissioner & Secretary, PHED, Govt. of Nagaland, Kohima.

AND WHEREAS, the RTI application dated 24.11.2015 was received by the Office of the Chief Engineer, PHED, Nagaland, Kohima vide Receipt No. 404 dated **26.11.2015** as evidenced on the body of the application.

AND WHEREAS, on not getting any response to his RTI application dated 24.11.2015 from the PIO, PHED, Nagaland, Kohima within the stipulated time, the applicant had preferred a complaint dated 02.03.2016 to the Commission. A copy of his complaint was also endorsed to the Commissioner & Secretary, PHED, Govt. of Nagaland and the Chief Engineer, PHED, Nagaland, Kohima.

AND WHEREAS, the Commission has decided to hear the complaint, giving opportunity to the parties on **21st April, 2016 (Thursday) at 11:00 AM** in the **Hearing Room of the Nagaland Information Commission, Old Secretariat Complex, Kohima.**
