WHEREAS under Section 18 of the Right to Information Act, 2005, the Nagaland Information Commission had, on 08.10.2015 received a complaint dated 08.10.2015 from Mr. Pamo Lam, Noklak Town, Tuensang, Nagaland, Mobile No. 9436875614, 8132917651, C/o Pukha Lam, S.A, Secretariat, Nagaland, Kohima Mobile No. 9402631777 stating that there was no information from the PIO, DUDA, Nagaland, Kohima to his RTI application dated 17.11.2014 till date.

AND WHEREAS, the above applicant had earlier submitted an RTI application dated **17.11.2014** addressed to the PIO, Directorate of Under Developed Areas (DUDA), Nagaland, Kohima alongwith the prescribed application fee of Rs. 10 (Rupees ten only) paid in cash seeking the following information under DUDA during **2006 to 2013**:-

1. *Total amount received from Govt of India and State Share Govt. of Nagaland (photocopy of Sanction Orders);*
2. *Name of Contractor/Supplier/Company/Firms (Photocopy of Work Orders of Sl. No. 1 to 6);*
3. *Give detail MB No. Bill voucher and date of payment.*
4. *Provide Actual Payment Receipt (APR) photocopy of each works.*

1. *Construction of approach road from ITC, Pangsha to Shingyu from 2006 to 2013.*
2. *Construction of Community Hall cum Indoor Stadium at ITC, Pangsha during 2010-11.*
3. *Upgradation of road from Pangsha Old to ITC, Pangsha during 2010-2011.*
DAN Model ITC Pangsha.
4. *Construction of road to DAN Model ITC Pangsha. 2010-2011 Rs. 100 lakhs.*
5. *Construction of road to DAN Model ITC Pangsha. 2011-2012 Rs. 40 lakhs.*
6. *DAN Model village ITC Pangsha Construction of Circular Road to DAN Model village ITC Pangsha 2012-1012 Rs. 100 lakhs.*

AND WHEREAS, the RTI application dated 17.11.2014 was received on the same day i.e. 17.11.2014 as evidenced on the body of the RTI application.

AND WHEREAS, on not getting any response to his RTI application dated 17.11.2014 from the PIO, DUDA, Nagaland, Kohima till date, the applicant had submitted a complaint dated 08.10.2015, stating that the PIO had refused to reply to his RTI application by giving excuses inspite of assuring to provide the information to the applicant on many occasions.

AND WHEREAS, the Commission has decided to hear the complaint, giving opportunity to the parties on **6th November, 2015 (Friday) at 12:00 PM** in the **Hearing Room of the Nagaland Information Commission, Old Secretariat Complex, Kohima.**
