**Subject: Closing Order of Complaint case.**

WHEREAS under Section 18 of the Right to Information Act, 2005, and in accordance to the Nagaland State Information Commission (Appeal Procedure) Rules, 2005, the Commission had heard for the third time on 20.12.2016 at 11:00 AM. the complaint dated **08.09.2016** submitted by Shri. Ishiwangbe Hinglak, AG Colony, Kohima, Mobile No. 8014975468, E-mail: [isihinglak@gmail.com](mailto:isihinglak@gmail.com) against the non-furnishing of information by the PIO within the stipulated time period.

AND WHEREAS, the Commission had, in three (3) hearings held on (i) 29.09.2016 at 1:00 PM. (ii) 25.10.2016 at 12:00 PM., and (iii) 20.12.2016 at 11:00 AM. passed decisions vide even No. dated 07.10.2016, 28.10.2016 and 21.12.2016 respectively.

AND WHEREAS, in compliance to the decision of the Commission dated 21.12.2016, the '**Deemed PIO**', Shri. M.
