AND WHEREAS, the applicant had earlier submitted an RTI application dated 23.05.2016 along with the prescribed application fee of Rupees 10/- in cash to the PIO, Nagaland Bamboo Development Agency (NBDA), Dimapur, Nagaland seeking the following information.

- ii. *Sanctioned letters received from the Department of Agriculture and Cooperation (DAC), Ministry of Agriculture, Government of India from 2009-10 to 2016-17.*
- iii. *Details of funds released by the State Government from 2009-10 to 2016-17.*
- iv. *Quarterly progress report submitted to the Department of Agriculture and Cooperation (DAC) from 2009-10 to 2015-16.*
- v. *District- wise lists of Beneficiaries with name, address/House Number and Phone Number, from 2009-10 to 2016-17.*
- vi. *Financial transaction details regarding the beneficiaries from 2009-10 to 2016-17 as stated below:*
 - a. *Scanned copy of cheques issued to the beneficiaries with their name on the cheque; and*
 - b. *Actual pay receipt (APR) signed by the beneficiaries.*
- vii. *Sanctioned letters issued to the District Mission Committees from 2009-10 to 2016-17.*
- viii. *Bank transaction details for release of funds to the District Mission Committees from 2009-10 to 2016-2017.*
- ix. *Details of the present members of Nagaland Bamboo Mission-Implementation Team (NBM-IT), NBDA as stated below:*
 - a. *Full Name, Designation and Phone Number*
 - b. *His/Her parent Department*
 - c. *Date of Joining NBM-IT, NBDA*

AND WHEREAS, the RTI application was received by the Public Authority on 24.05.2016 as evidenced on the body of the application.

AND WHEREAS, on receipt of the RTI application, Dr. K. Vikato Sumi, Deputy TL NBDA had, vide letter dated 31.05.2016 informed the applicant the cost of information amounting to about Rs. 20,000/- (Rupees twenty thousand only).

AND WHEREAS, the applicant had vide e-mail dated 31.05.2016 while acknowledging the receipt of the letter from Dr. K. Vikato Sumi, Deputy TL NBDA asked him to go ahead with the compilation of the information and his willingness to pay some advance bill amount.

AND WHEREAS, on not getting any further response from the Public Authority, the applicant vide letter dated 22.06.2016 requested the Public Authority to clarify on the due date to provide the information.

AND WHEREAS, on not getting any response, the applicant submitted a complaint dated 08.09.2016 to this Commission.

AND WHEREAS, the Commission had decided to hear the complaint, giving opportunity of being heard to the parties on **29th September, 2016 (Thursday) at 1:00 P.M** in the **Hearing Room of Nagaland Information Commission, Old Secretariat Complex, Kohima.**
