WHEREAS, under Section 18 of the RTI Act, 2005, a complaint dated 24.09.2016 has been received on 29.09.2016 from an applicant, M/S Habemo Ngullie, Govt. Registered Contractor & Supplier PWD CI-1/245, Nagaland, Kohima stating that there was no response to his RTI application dated 30.06.2016 till date which was addressed to the Chief Engineer, PWD (R&B), Nagaland, Kohima.

*(02) 20mm premixed carpeting (PC) of SC*

*(03) CRSM R/Wall at 0.3.50/0.250 km*

*(04) Masonry open surface drain etc allotted in the name of the aforementioned firm.*

AND WHEREAS, the RTI application dated 30.06.2016 was posted on 07.07.2016, however, on not getting any response to his RTI application within the stipulated time frame of 30 (thirty) days, the applicant had preferred a complaint dated 24.09.2016 before this Commission.
