**Subject: Closure of Appeal case.**

WHEREAS under Section 19 of the Right to Information Act, 2005, the Nagaland Information Commission have received a second appeal dated 29.04.2013 from an appellant, Irangbui Hingleu, Director, Legacy Explorers, Mid night market Complex, No. 8, Jalukie, Nagaland – 797110, Mobile: 9436409423, wherein the applicant (now appellant) stated that he did not receive any information to his RTI application dated 27.03.2012, even after filing first appeal dated 20.11.2012 to the Director & First Appellate Authority, Rural Development, Nagaland, Kohima, which was submitted against the non response of the Project Director & PIO, DRDA, Peren.

AND WHEREAS, the applicant had earlier submitted RTI application dated 27.03.2012 alongwith the prescribed fee paid in cash, which was received in the DRDA Office, Peren on 29.03.2012, seeking information on the following:-

- i. Photocopy of Bank Account pass-book showing latest 3 months transactions.
- ii. Photocopy of latest Sanction Order/letter from the Ministry of Rural Development, Government of India or DDO of the State.
- iii. Latest Budget break-ups, clearly showing all budget heads in CD format only, including NREGA, PMGSY, SGSY, DRDA, NRLM and sub-heading such as projects given to individual or VDB indicating name of project and sanctioned amount.

AND WHEREAS, on not receiving any response or information from the Project Director & PIO, DRDA, Peren within the stipulated time frame, the applicant(now the appellant) stated that a reminder letter was sent to the PIO on 24.09.2012 but there was no response from the Project Director & PIO, DRDA, Peren. However, a copy of the reminder letter dated 24.09.2012 was not found enclosed.

AND WHEREAS, the applicant(now the appellant) had preferred first appeal dated 20.11.2012 to the Director & First Appellate Authority, Rural Development, Nagaland, Kohima, which was submitted against the non response of the Project Director & PIO, DRDA, Peren within the stipulated time.

AND WHEREAS, in response to the first appeal dated 20.11.2012, the Director & First Appellate Authority, Rural Development, Nagaland, Kohima had, vide letter No. DRD/ME/RTI-2/09 (Pt-I)/343 dated 04.12.2012 directed the Project Director & PIO, DRDA, Peren to furnish the information within 15 days from the date of receipt of his letter.

AND WHEREAS, on not receiving any response or information till date, the applicant(now the appellant) had preferred second appeal dated 29.04.2013 to the Commission.

AND WHEREAS, the Nagaland Information Commission had vide Notice of even No. dated 10.06.2013 notified to hear the appeal, giving opportunity to the parties, on **18<sup>th</sup> June, 2013 (Tuesday) at 1:00 PM** in the **Hearing Room of the Nagaland Information Commission, Old Secretariat Complex, Kohima.**

AND WHEREAS, the Commission had observed that the first appeal dated 20.11.2012 was filed before the Director & First Appellate Authority, Rural Development, Nagaland, Kohima after nearly **seven (7) months** from the date of the expiry of the RTI application dated 27.03.2012, and also that the second appeal dated 29.04.2013 was filed before the Commission after nearly **four (4) months** from the date of the expiry of the first appeal dated 20.11.2012.

AND WHEREAS, on the date of the hearing on 18.06.2013, the appellant did not appear before the Commission, however, a **withdrawal letter dated 15.06.2013** of the appellant was received from the respondent, wherein the appellant stated that since the required information was received on two (2) occasions viz. from Shri. Moakaba, Programme Officer (MGNREGA), DRDA, Peren vide letter No. DRDA/PRN/RTI-1/2013-14 dated 12.05.2013 and from Ms. Linda Solo, Project Director, DRDA, Peren vide letter No. DRDA/PRN/RTI-1/2013-14 dated 15.06.2013, the appellant had decided to withdraw the complaint.

AND WHEREAS, the Commission had accepted the **withdrawal letter dated 15.06.2013** submitted by the appellant;

NOW THEREFORE, it is notified to the following parties that the appeal case is hereby declared closed:-

- i. The Director & First Appellate Authority, Rural Development, Nagaland, Kohima;
- ii. The Project Director & PIO, DRDA, Peren, Nagaland; and
- iii. The appellant, Irangbui Hingleu, Director, Legacy Explorers, Mid night market Complex, No. 8, Jalukie, Nagaland – 797110, Mobile: 9436409423.
