Subject: Closing of appeal case.

WHEREAS under Section 19 of the Right to Information Act, 2005, the Nagaland Information Commission have received a second appeal dated 30.05.2013 from an appellant, Shri. Hokishe N. Swu, Chekiye Village, Dimapur, Nagaland, Mobile No. 9089896123, stating that there was no response from the First Appellate Authority, School Education, Nagaland, Kohima to his first appeal dated 12.02.2013 (received on 14.02.2013) which was filed against the unsatisfactory response received from the Director & Nodal Officer, MDM, School Education, Nagaland, Kohima.

AND WHEREAS, on receipt of the RTI application dated 12.10.2012 alongwith the prescribed fee which was addressed to the PIO, Office of the Director, School Education, Kohima seeking certain information, the Director & Nodal Officer, MDM, School Education, Nagaland, Kohima had, vide letter No. ED/MDM/RTI/2007-08 dated 26.11.2012 furnished some information.

AND WHEREAS, on being not satisfied with the information so received, the applicant had submitted first appeal dated 12.02.2013 to the First Appellate Authority, School Education, Nagaland, Kohima.

AND WHEREAS, on getting no response from the First Appellate Authority, School Education, Nagaland, Kohima to his first appeal dated 12.02.2013 within the stipulated time, the applicant(now the appellant) had preferred Second Appeal dated 30.05.2013 before this Commission.

AND WHEREAS, since the First Appellate Authority, School Education, Nagaland, Kohima had not acted upon the first appeal dated 12.02.2013 which was received on 14.02.2013, the Commission had, vide its directive of even No. dated 12.07.2013 directed the Principal Director & First Appellate Authority, School Education, Nagaland, Kohima to hold a hearing of the parties (PIOs and the appellant) and pass a quasi-judicial decision **by 26.07.2013**, with a copy of the decision to this Commission and the appellant.

AND WHEREAS, the Commission had, vide letter of even No. dated 07.09.2013, notified the hearing of the appeal, giving opportunity to the parties, on **20th September, 2013 (Friday) at 1:00 PM** in the **Hearing Room of the Nagaland Information Commission, Old Secretariat Complex, Kohima.**

AND WHEREAS, in compliance to the direction of the Commission, the First Appellate Authority, School Education, Nagaland, Kohima had, vide letter No. ED/MDM/RTI/2007-08 dated 23.07.2013 submitted that he had heard the first appeal dated 12.02.2013 on 23.07.2013 at 11:00 AM and had within the stipulated time fixed by the Commission passed quasi-judicial decision in the presence of the appellant, and that the appellant had expressed satisfaction as recorded in the quasi-judicial decision, the Commission had decided to declare the **case closed**.

AND WHEREAS there is no further complain from the appellant even after sufficient time had elapsed.

NOW THEREFORE, it is notified to the following parties that the appeal case is hereby declared closed:-
