Subject: Order for closing of appeal case.

WHEREAS under Section 19 of the Right to Information Act, 2005, and in accordance to the Nagaland State Information Commission (Appeal Procedure) Rules, 2005, the Nagaland Information Commission had, **on 26.11.2013** heard the second appeal dated 09.09.2013 received from an appellant, Shri. Deenabhandhu Panda, F/o Gaurav Kumar Panda, Office of the District Education Officer, Kiphire, Nagaland, Mobile No. 9436007896/8974111249 wherein he was not satisfied with the reply of the First Appellate Authority, NBSE, Nagaland, Kohima to his First Appeal dated 30.07.2013, which was submitted against the unsatisfactory response of the Asstt. Academic Officer & PIO, NBSE, Nagaland, Kohima.

AND WHEREAS the Commission had, after hearing both the parties **on 26.11.2013**, passed decision on the second appeal vide this Commission's Decision of even No. dated **13.12.2013**;

AND WHEREAS, in compliance to the **Point No. 3** of the decision of the Commission dated 13.12.2013, the Public authority i.e. the NBSE (Nagaland Board of School Education), Nagaland, Kohima had, vide letter No. NBE-19/G-RTI/2013-14/2391 dated 03.12.2013 submitted copies of the following:-
