Subject: Notice for Hearing on 4th March, 2014 (Tuesday) at 1:00 PM.

WHEREAS under Section 19 of the Right to Information Act, 2005, the Nagaland Information Commission have received a Second Appeal dated 28.01.2014 from an appellant, Shri. K. Thong, Member, Vigilance Cell, NPCC, Congress Bhavan, Kohima, Mobile No. 9612169565, stating that there was no response from the Director & FAA, Social Welfare, Nagaland to his first appeal dated 21.11.2013 which was submitted against the non-response of the PIO, Directorate of Social Welfare, Nagaland, Kohima to his RTI application dated 18.10.2013.

AND WHEREAS, earlier the applicant had submitted a RTI application dated **18.10.2013** addressed to the PIO, Directorate of Social Welfare, Nagaland, Kohima alongwith an application fee of Rs. 10/-, seeking information relating to the implementation of Supplementary Nutrition Programme (SNP) with the following particulars:-

1. Full name of S.B. Tiwari, Contact No. & communication address.
2. Designation/status of S.B. Tiwari and relation with M/s Rausheena Udyog Ltd., Guwahati and Reach Out Society, Duncan Bosti, Dimapur with documentary proof.
3. Full name, Contact No. & communication address of Limaakum (Chairman of Reach Out Society).
4. documentary proof of Limaakum having drawn SNP payment for Reach Out Society.
5. Full name, Contact No. & communication address of S. K.
6. Designation/status of S.K and relation with Khoyo Tribal Women Welfare Society, Midland, Kohima.
7. Name of Chairman, Members & communication address of Surho Tribal Welfare Society, Kohima.
8. Name of Chairman, Members & communication address of Rural Tribal Welfare Organisation, Dimapur.
9. Photocopy of authorisation/approval for Kudecho Khamo to draw the SNP payment since March, 2010 till date.

AND WHEREAS, the RTI application dated 18.10.2013 was received by the public authority on **19.10.2013** as evidenced on the copy of the above RTI application.

AND WHEREAS, on not getting any response from the concerned PIO, Social Welfare, Nagaland, Kohima within the stipulated time frame of the 30 days under the RTI Act, 2005, the applicant had preferred first appeal dated **21.11.2013** to the Director & FAA, Social Welfare, Nagaland, Kohima. The first appeal dated 21.11.2013 was received by the public authority on the same day i.e. **21.11.2013** as evidenced on the copy of the first appeal.

AND WHEREAS, on not getting any response from the Director & FAA, Social Welfare, Nagaland, Kohima to his first appeal dated 21.11.2013, the applicant(now the appellant) had preferred second appeal dated **28.01.2014** before this Commission.

AND WHEREAS, since there was no response to the RTI application dated 18.10.2013 and the subsequent first appeal dated 21.11.2013, the Commission has decided to hear the appeal, giving opportunity to the parties, on **4th March, 2014 (Tuesday) at 1:00 PM** in the **Hearing Room of the Nagaland Information Commission, Old Secretariat Complex, Kohima.**
