Sub: Closing Order of Appeal Case.

WHEREAS, the Commission had, on two occasions on 18.11.2016 at 11:00 A.M and 20.01.2017 at 12:00 Noon heard the second appeal dated 15.09.2016 submitted by Smti.Chemtila Sangtam, Works & Housing, Loan (Br), Nagaland Civil Secretariat, Kohima, Mobile No.8731924903 against the non-satisfaction of information furnished by the PIO and the FAA, Nagaland Public Service Commission (NPSC), Nagaland, Kohima in response to her RTI application dated 31.03.2016 and subsequent first appeal dated 16.05.2016.

AND WHEREAS, after the hearing on 18.11.2016 at 11:00 A.M and 20.01.2017 at 12:00 Noon, the Commission had passed decision of even No. dated 28.11.2017 and 09.05.2017 respectively.

AND WEHERAS, on getting no compliance to the above decision from the Deputy Secretary & PIO, NPSC, the Commission had, vide letter of even No. dated 14.09.2017 directed to ascertain satisfaction or non-satisfaction of information so furnished to the applicant (now appellants) within 2 (Two) weeks from the date of receipt of the directive, with a copy to this Commission.

AND WHEREAS, in compliance to the above directive of the Commission, Shri. Kelhouseto Nakhro, Deputy Secretary & PIO had, vide letter No.NPSC/RTI/2005(VOL-II) dated 11.09.2017 with a copy to this Commission, wrote to the applicant (now appellants) for confirmation of the satisfaction or non-satisfaction of the information furnished to him within 2 (Two) weeks so as to close the case to his second appeal.

AND WHEREAS, since the Commission has not received the above confirmation from the applicant (now appellants), the Commission had, vide letter of even No. dated 22.03.2018 directed the Deputy Secretary & PIO, NPSC to issue final reminder to the applicant (now appellants) specifying a certain limit for submission of the confirmation with a copy to this Commission.

AND WHEREAS, in compliance to the above directive of the Commission, the Deputy Secretary & PIO, NPSC vide letter No.NPSC/RTI/2005(VOL-II) dated 17.04.2018 had again reminded to the applicant (now complainant) to confirm satisfaction or non-satisfaction of the information within 2 (Two) weeks from the date of issue of the letter.

AND WHEREAS, since the above compliances have been received from the Public Authority and though sufficient time had lapsed, there was no response from the applicant (now appellants), suggesting that the applicant have no interest to pursue his case further, the Commission has decided to close the appeal case.

NOW THEREFORE, it is notified to all the parties that this appeal case is hereby declared as **closed**.
