Sub: Closing Order of Appeal Case.

WHEREAS, the Commission had, on two occasions on 23.11.2016 at 12:30 P.M and 28.11.2017 at 2:00 P.M. heard the second appeal dated 02.11.2016 submitted by Shri. Amos Odyuo, President, Lotha Students' Union, Head Post Office, Kohima, P.O. Box No.950, Kohima, Nagaland, mobile No.89740267, 700505909 against the non-satisfaction of the reply of the Secretary & FAA, Nagaland Public Service Commission (NPSC) to his first appeal dated 23.09.2016 and which was submitted against the non-satisfaction of the information furnished by the PIO in reply to his RTI application dated 11.08.2016.

AND WHEREAS, after the hearing on 23.11.2016 at 12:30 P.M and 28.11.2017 at 2:00 P.M, the Commission had passed decision of even No. dated 08.12.2017 and 05.12.2017 respectively.

AND WHEREAS, in compliance to the decision of the Commission of even No. dated 05.12.2017, Shri. Kelhouseto Nakhro, Deputy Secretary & PIO had, vide letter No.NPSC/RTI/2005(VOL-II) dated 11.12.2017 wrote to the applicant (now appellant) for confirmation of the satisfaction or non-satisfaction of the information furnished to him within 2 (Two) weeks so as to close the case to his second appeal, with a copy to this Commission.

AND WHEREAS, since the Commission has not received the above confirmation from the applicant (now appellant), the Commission had, vide letter of even No. dated 22.03.2018 directed the Deputy Secretary & PIO, NPSC to issue final reminder to the applicant (now appellant) specifying a certain limit for submission of the confirmation with a copy to this Commission.

AND WHEREAS, in compliance to the above directive of the Commission, the Deputy Secretary & PIO, NPSC vide letter No.NPSC/RTI/2005(VOL-II) dated 17.04.2018 had again reminded to the applicant (now complainant) to confirm satisfaction or non-satisfaction of the information within 2 (Two) weeks from the date of issue of the letter.

AND WHEREAS, since the above compliances have been received from the Public Authority and though sufficient time had lapsed, there was no response from the applicant (now appellant), suggesting that the applicant have no interest to pursue his case further, the Commission has decided to close the appeal case.

NOW THEREFORE, it is notified to all the parties that this appeal case is hereby declared as closed.
