### **Sub: Closing Order for Appeal Case.**

WHEREAS, under Section 19 of the RTI Act, 2005 and in accordance to the Nagaland State Information Commission (Appeal Procedure) Rules, 2005, the Commission had, on 18.01.2017 at 1:00 P.M. and 24.04.2018 at 12:00 Noon heard the second appeal dated 22.08.2016 submitted by Shri. Prem Singh S/o Shri. Hoshiyar Singh, Hadaula Village, Police Station & District Jind (Haryana), Mobile No. 9466766126 against the non-response of the Transport Commissioner & FAA, Nagaland, Kohima to his first appeal dated 06.07.2016 which was submitted against the non-satisfaction of the information furnished to him by the RTO, Mokokchung, Nagaland in response to his RTI application dated 11.05.2016.

AND WHEREAS, after the hearing on 18.01.2017 at 1:00 P.M. no written decision could be issued as the office building including all office records, files, furniture, equipment, were completely destroyed in the fire on 02.02.2017 during the public unrest in connection with the Urban Local Bodies election. However, basing on the oral decision during the hearing held on 18.01.2017, the PIO had furnished the information to the applicant (now appellant).

AND WHEREAS, after the second hearing held on 24.04.2018 at 12:00 Noon, the Commission had passed decision of even No. dated 30.04.2018 wherein the PIO was directed to confirm satisfaction or non-satisfaction of the information from the applicant (now appellant) within 1 month and inform the Commission accordingly or on the expiry of the 1 month time.

AND WHEREAS, in compliance to the above Commission decision dated 30.04.2018 on **Point No.1**, Shri.Iheto Achumi, Regional Transport Officer & PIO, Mokokchung, Nagaland had, vide letter No.RTO-MKG/RTI/G-30/08/7639-41 dated 16.05.2018 and with a copy to the Commission wrote to the applicant (now appellant) for confirmation of satisfaction or non-satisfaction of the information within 30 days which was furnished to him on 25.01.2017, stating that in case of non-response the information furnished shall be considered as satisfied.

AND WHEREAS, in compliance to the **Point No.2** of the decision of the Commission dated 30.04.2018, Shri. Iheto Achumi, Regional Transport Officer & PIO, Mokokchung, Nagaland had, vide letter No.RTO-MKG/RTI/G-30/08/7714-16 dated 29.06.2018 submitted that there was no response from the applicant (now appellant) regarding his satisfaction or non-satisfaction of the information even after the expiry of 1 month's time limit.

AND WHEREAS, sufficient time had lapsed there was no response or further appeal from the applicant (now appellant) even after the PIO had furnished the information on 25.01.2017, suggesting that the applicant was satisfied with the information furnished by the PIO.

AND WHEREAS, since there was no response from the applicant (now appellant) within the time given as decided in the last hearing, the Commission has decided to close the appeal case.

NOW, THEREFORE, it is notified to all the parties that this appeal case is hereby declared as **closed**.
