**Subject: Closing Order of Appeal case.**

WHEREAS under Section 19 of the Right to Information Act, 2005, and in accordance to the Nagaland State Information Commission (Appeal Procedure) Rules, 2005, the Nagaland Information Commission had, on 29.07.2016 at 12:00 P.M and 26.10.2016 at 1:00 P.M heard the second appeal vide No. PGD-1/2015-16 dated 09-06-2016 submitted by Shri. Moa Emchen, Member Secretary, PGD, NPCC, Mobile No. 9862749595 and Shri. Kedou Wetsah, Member, PGD, NPCC, Mobile No. 9436001640 against the non response of the First Appellate Authority, Office of the DGP, Nagaland, Kohima, to their First Appeal vide letter No. PGD-1/2015-16 dated NIL which was submitted against the non-furnishing of information by the PIO to their RTI application dated NIL.

AND WHEREAS, the Commission had, after the second hearing on 26.10.2016 at 1:00 P.M, passed decision vide even No. dated **28.10.2016**, imposed penalty @ Rs. 250 per day for the total **84 days** of delay amounting to a total amount of Rs. 21,000 (Rupees twenty one thousand only), which was be shared among the following PIO and “deemed PIOs” for contributing to the delay in furnishing the information as shown below:-
