**Subject: Closing Order of Appeal Case.**

WHEREAS under Section 19 of the Right to Information Act, 2005, and in accordance to the Nagaland State Information Commission (Appeal procedure) Rules, 2005, the Nagaland Information Commission had heard the second appeal dated 16.06.2016 submitted by Shri Narinder Kumar, SCO 147-148, Second Floor, Sector 9C, Madhya Marg, Chandigarh on two occasions i.e., on 20.09.2016 at 11:00 A.M and on 16.11.2017 at 11:00 A.M.

AND WHEREAS, after the second hearing on 16.11.2017 at 11:00 A.M, the Commission had, vide even No. dated 30.11.2017 passed its decision wherein the District Transport Officer & PIO, Motor Vehicles Department, Zunheboto was directed to declare in the form of Sworn Affidavit that the Driving Licence No. 6075/NTV/2011 was not genuine since there was no records pertaining to the said Driving Licence in the Office of the District Transport Officer, Zunheboto.

AND WHEREAS, in compliance to the decision of the Commission of even No. dated 30.11.2017, the District Transport Officer & PIO, Motor Vehicles Department, Zunheboto had, vide letter No. DTO-Z/DL-V/2017-18/129 dated 19.12.2017 submitted to this Commission the Sworn Affidavit bearing Registration No. 01 dated 20.12.2017 declaring that the Driving Licence No. 6075/NTV/2011 has not been issued from the Office of the District Transport Officer, Zunheboto and also, the Driving Licence No. 58707/NTV/Z/2010 was fake/not genuine.

AND WHEREAS, since the above compliance has been received, the Commission has decided to close the appeal case.

NOW THEREFORE, it is notified to all the parties that the appeal case is hereby declared as **closed.**
