Subject: Closing Order of Appeal Case.

WHEREAS, under Section 19 of the Right to Information Act, 2005, and in accordance to the Nagaland State Information Commission (Appeal procedure) Rules, 2005, the Nagaland Information Commission had received a second appeal dated 12.07.2016 submitted by Shri. S. Lepzung Jamir, Managing Director (NESMS) and Social Activist, Tuli, Mokokchung, Nagaland, Mobile No. 8413946471, email: nesmstuli@gmail.com.

AND WHEREAS, the Commission had heard the second appeal on 08.09.2016 at 12:00 P.M and 13.03.2018 at 12:00 P.M, and after the hearing passed its decision of even No. dated 26.09.2016 and 20.03.2018 respectively.

AND WHEREAS, in compliance to the decision of the Commission dated 20.03.2018, the Commission had, vide letters No. NHM/NL-15/7/Pt-C/2015-16/0062 dated 24.04.2018 and NHM/NL-15/37/Pt-C/2015-16/0074 dated 27.04.2018 received a copy of the Treasury Challan bearing No. 59 dated 20.04.2018 for an amount of ` 8,250/- (Rupees eight thousand two hundred and fifty only) which was imposed on Dr. Yankho Lotha, (Retd) Former Mission Director & PIO, National Health Mission for failing to furnish the information to the applicant (now appellant) within the prescribed period of 30 (thirty) days without any reasonable cause.

AND WHEREAS, inspite of the sufficient opportunity and time given to the applicant (now appellant), since there was no response from the applicant (now appellant) till date and that the above Treasury Challan has been received, the Commission has decided to close the appeal case.
