WHEREAS, the Commission had, on 19.02.2019 at 1:00 P.M. heard the second appeal dated 28.11.2018 submitted by Shri. Molo Jamir, Advocate, Principal District & Sessions Court, Mokokchung, Nagaland/ Home address: House No.38, Lijaba Lijen Ward, Mokokchung, Nagaland, email:molojmair@gmail.com, Mobile No.9862127003/ 9862127003/ 7005040093 against the denial of information by Er. K. Theunuo, Chief Engineer & First Appellate Authority, O/o the Chief Engineer PWD (National Highway), Nagaland, Kohima to his first appeal dated 12.09.2018 which was submitted against the non-satisfaction of information furnished by Er. Chubatoshi, Executive Engineer, PWD (National Highway), Division-II, Mokokchung, Nagaland to his RTI application vide letter Ref:MJ/RTI/17/18 dated 17.07.2018.

AND WHEREAS, after the hearing on 19.02.2019 at 1:00 P.M., the Commission had passed decision vide even No. dated 23.02.2019.

AND WHEREAS, in compliance to the **Point No.1** of the decision of the Commission dated 23.02.2019, Er. Chubatoshi, Executive Engineer & PIO, PWD (National Highway), Division-II, Mokochung, Nagaland had, vide letter No.EE/MKG/NH/T-48/2018-19 dated 11.03.2019 furnished the information to the applicant (now appellant).

AND WHEREAS, also in compliance to the **Point No.2** of the decision of the Commission dated 23.02.2019, the applicant (now appellant), Shri. Molo Jamir had, vide letter No.MJ/RTI/17/18 dated 26.03.2019 wrote to the PIO, PWD (National Highway), Division-II, Mokokchung, Nagaland and with a copy to the Commission stating that he was not satisfied with the information/ document furnished by the PIO, since it was a document prepared by his office and not the original list and had further requested to furnish the complete original list of amount sanctioned as compensation by the MoRTH to each and every affected landowner under Unger village, Chuchuyimlang village and Mongsenyimti village in the interest of justice.

AND WHEREAS, the Commission had not received any compliance to the **Point No.3** of its decision dated 23.02.2019 till date.
