Subject: Notice for Hearing on 28th November (Tuesday), 2017 at 2:00 P.M.

WHEREAS, after hearing the appeal case on 23.11.2016, the Commission had passed its decision vide even No. dated 08.12.2017, wherein the Deputy Secretary & PIO, NPSC was directed to furnish the information sought by the applicant within two (2) weeks from the date of receipt of the decision of the Commission.

AND WHEREAS, on receipt of the decision, the Deputy Secretary & PIO, NPSC had, vide letter No. NPSC/RTI/2015 dated 17.12.2016 requested the Commission for extension of time till 20.01.2017 to let the NPSC discuss the matter in detail and thereafter furnish the information sought.

AND WHEREAS, the Deputy Secretary & PIO, NPSC had, vide letter No. NPSC/RTI/2015 dated 18.01.2017 requested the Commission to review its decision and exempt the NPSC from disclosing the information sought on the ground that it was a matter of policy of the NPSC not to disclose marks of merit list as a whole and disclosing marks of merit list of all the candidates to an individual or organisation may not be in the interest of the public.

AND WHEREAS, the Commission had vide letter of even No. dated 14.09.2017 directed the Deputy Secretary & PIO, NPSC that since in another similar appeal case No. NIC/Appeal-12/2016-17 (Smti. Chemtila Sangtam vs. NPSC), the information sought i.e., the marks obtained by the Sangtam candidates in the Mains exam and Viva Voce in the declared result of NCS, NPS, NSS and Allied Services Examination, 2014 had been furnished, therefore, the information sought by the applicant should also be furnished within two (2) weeks from the date of receipt of the directive and also confirm satisfaction or non-satisfaction of the information so furnished and submit to this Commission for further necessary action.

AND WHEREAS, on not getting any response from the Deputy Secretary & PIO, NPSC to the directive issued by the Commission, the Commission has decided to hear the appeal case again **on 28th November (Tuesday), 2017 at 2:00 P.M.** in the **Hearing Room of Nagaland information Commission, Below Raj Bhavan, Officers' Hill Colony, Nagaland, Kohima.**
