Subject: Notice for Hearing on 8th March, 2018 (Thursday) at 1:00 P.M.

WHEREAS, under Section 19 of the RTI Act, 2005, the Commission had received a second appeal dated 10.12.2016 submitted by Smti. Zeneisüle Ate Loucü, C 1/6, 2nd Floor, Sector 52, Ardee, Gurgaon, Haryana -122001, Mobile No. 08415068612, email: ateau@hotmail.com against the non-response of the Joint Secretary & PIO, Environment, Forest & Climate Change Department, Nagaland, Kohima to her RTI application dated 30.06.2016 and the First Appellate Authority, Environment, Forest & Climate Change Department, Nagaland, Kohima to her subsequent first appeal dated 29.09.2016.

AND WHEREAS, the applicant, had earlier submitted an RTI application dated **30.06.2016** addressed to Shri. Henkhohao Singson, Joint Secretary & PIO, Environment, Forest & Climate Change Department, Nagaland, Kohima along with application fee of Rs. 10/- paid through IPO bearing No. 69E 929753 seeking the following information regarding appointment order/orders of Roko/ Roko Angami, Football Coach in the Directorate of Youth Resources & Sports, Nagaland, Kohima:

- i. Please give me inspection of all files related to Roko/ Roko Angami, Football Coach in the Directorate of Youth Resources & Sports, Nagaland, Kohima.*
- ii. Please allow me to take digital photographs and/or photocopies of the desired information from the files.*

AND WHEREAS, on receipt of the RTI application dated 30.06.2016, the Joint Secretary & PIO, Department of Environment, Forest & Climate Change, Nagaland, Kohima had, vide letter No. FOR/ESTT-(RTI)-80/2005(VOL-II)/644 dated **13.07.2016** transferred the RTI application to the Commissioner & Secretary, Department of Youth Resources & Sports, Nagaland, Kohima with a copy for information to the applicant as the information sought pertained to the Department of Youth Resources & Sports.

AND WHEREAS, on not getting any response from the Joint Secretary & PIO, Department of Environment, Forest & Climate Change, Nagaland, Kohima to her RTI application 30.06.2016 within the stipulated time period of 30 (thirty) days, the applicant had submitted a first appeal dated **29.08.2016** to the First Appellate Authority, Department of Environment, Forest & Climate Change, Nagaland, Kohima.

AND WHEREAS, on receipt of the first appeal dated 29.08.2016, the Commissioner & Secretary & First Appellate Authority, Department of Environment, Forest & Climate Change, Nagaland, Kohima had, vide letter No. C&S/EFCC/RTI/2016 dated 05.09.2016 directed the Joint Secretary & PIO to furnish the requisite information to the applicant, and further, in the case if the information sought was not within the purview of the Department, the Joint Secretary & PIO was directed to transfer the first appeal to the Department concerned to furnish the requisite information to the applicant.

AND WHEREAS, in compliance to the directive of the Commissioner & Secretary & First Appellate Authority, the Joint Secretary & PIO, Department of Environment, Forest & Climate Change, Nagaland, Kohima had, vide No. FOR/ESTT-(RTI)-80/2005(Vol-II)/787 dated 06.09.2016 forwarded the first appeal to the Commissioner & Secretary, Youth Resources & Sports, Nagaland, Kohima with a copy for information to the applicant (now appellant) for information as the appeal pertained to the Department of Youth Resources & Sports.

AND WHEREAS, on not getting any decision from the First Appellate Authority, Department of Environment, Forest & Climate Change, Nagaland, the applicant (now appellant) had preferred a second appeal dated **10.12.2016** before this Commission.

AND WHEREAS, since the Commission observed that the appeal pertained to the Department of Youth Resources & Sports Nagaland, Kohima and that the first appeal was not heard by the First Appellate Authority, the Commissioner & Secretary & FAA, Department of Youth Resources & Sports

Nagaland, Kohima was directed to take up the first appeal by hearing the parties i.e. the applicant and the PIO concerned and pass decision and thereafter submit a copy of the decision to this Commission.

AND WHEREAS, since the office building which was located in the Old Secretariat Complex was burnt down during the public unrest on 02.02.2017 wherein all the files, records, office furniture, equipment, etc. were completely destroyed, the Commission had, vide letter of even No. dated **18.08.2017** requested the Commissioner & Secretary & FAA, Youth Resources & Sports, Nagaland to submit copy of the decision on the first appeal dated **29.08.2016** and the photocopies of all the documents and correspondences relating to the appeal case.

AND WHEREAS, in compliance to the directive of the Commission of even No. dated 18.08.2017, the Under Secretary, Department of Youth Resources & Sports, Nagaland had, vide letter No. YRS/ESTT-5/2010(PT) dated 29.08.2017 submitted photocopies of the documents and correspondences relating to the appeal case, however, the decision of the First Appellate Authority was not found enclosed.

AND WHEREAS, the Commission has decided to hear the appeal giving opportunity of being heard to all the parties on **8th March, 2018 (Thursday) at 1:00 P.M in the Hearing Room of Nagaland Information Commission, Below Raj Bhavan, Officers' Hill Colony, Nagaland, Kohima.**
