WHEREAS under Section 19 of the RTI Act, 2005 and the Nagaland Information Commission (Appeal procedure) Rules, 2005, the Commission had on 29.07.2016 at 2:00 P.M heard the second appeal submitted by Shri. Haiying, Member, PGD, NPCC, Mobile No. +91 9402908307 vide letter No. PGD-1/2015-16 dated 08-06-2016 against the non-furnishing of the requisite information from the First Appellate Authority in response to their First Appeal dated NIL which was submitted against the incomplete information furnished by the PIO to their RTI application dated NIL.
