**Subject: Notice for Hearing on 29<sup>th</sup> July, 2016 (Friday) at 2:00 P.M.**

WHEREAS under Section 19 of the Right to Information Act, 2005, a second appeal vide No. PGD-1/2015-16 dated 08-06-2016 has been received on 13-06-2016 from Kedou Wetsah, Member, PGD, NPCC, Mobile No. +91 9436001640 and Haiying, Member, PGD, NPCC, Mobile No. +91 9402908307 against the non-furnishing of the requisite information from the First Appellate Authority in response to their First Appeal dated NIL which was submitted against the incomplete information furnished by the PIO to their RTI application dated NIL.

AND WHEREAS, the above applicants had earlier submitted an RTI application vide No. PGD-1/2015-16 dated NIL addressed to the PIO, Department of New and Renewable Energy, Nagaland, Kohima along with the prescribed application fee of Rs. 10/- (Rupees ten only) paid in cash seeking information regarding Mini Hydro Project taken up by the Department of New and Renewable Energy with the following details:-

- i. Furnish total number of Mini Hydro Project taken up by the Department in last five (5) years (i.e., 2010-11, to 2015).*
- ii. Furnish DPR/Work estimate of total Project in both Hard and Soft copy.*
- iii. Furnish Xerox copy of the NIT call of every Project.*
- iv. Furnish in detail the profile of the company/firm to whom the work was awarded.*
- v. Furnish a copy of work order for each project to which contract was awarded.*
- vi. Furnish the total Amount received from the Ministry. Govt. of India for every project. Furnish Xerox copy of sanction letter of each project.*
- vii. Furnish utilization and completion certificate if any of the Project has been completed.*
- viii. Furnish in detail the Actual Pay Receipt (APR) of each project.*
- ix. Furnish in detail the voucher/invoice from which firm/Company that both the electrical and civil work items/articles were purchased.*

AND WHEREAS, on receipt of the RTI application on 08-12-2015 by the APIO, Department of New and Renewable Energy as evidenced on the body of the RTI application, Er.Thungpemo Ezung, Asst. Director and PIO, Directorate of New and Renewable Energy, Nagaland, Kohima had, vide letter No. DNRE/RTI-4/2010(pt-II)/364 dated 08-01-2016 informed the applicants about the cost of the information amounting to Rs. 926/- (Rupees nine hundred and twenty six only) and had also vide letter No. DNRE/RTI-4/2010(pt-II)/364 dated 08-01-2016 furnished the information to the applicants.

AND WHEREAS, on receipt of information furnished by the PIO, the applicants had submitted First Appeal vide letter No. Nil dated Nil addressed to the FAA, Directorate of New and Renewable Energy stating that the PIO had furnished incomplete and unsatisfactory information.

AND WHEREAS, on receipt of the First Appeal vide letter No. Nil dated Nil on 08-02-2016, the Director & FAA had, after hearing the applicants (now appellants), PIO and APIO on 25-02-2016 at 12:30 P.M, passed his decision vide No. DNRE/RTI-4/2010 (PT-II)/6327 dated 25-02-2016 stating that the information for Sl. No. 1, 2, 3, 4 and 6 of the RTI application were satisfied, however, from Sl. No. 5, 7, 8 and 9 given below should be furnished to the applicants (now appellants) on or before 05-03-2016:-

- i. Utilization certificate for Thiza ru MHEP*
- ii. APR for Thiza ru MHEP*
- iii. Completion certificate for Mayemong MHEP.*
- iv. APR (Mobilization Advance payment) for Noiroi MHEP.*

- v. Lettter of Authorization from M/S Sandstone for receiving payment.
- vi. Voucher and Invoice from the firm/company for Mayamong MHEP, Thiza ru MHEP, Noiroi MHEP and Tsutsung MHEP,

AND WHEREAS, in compliance to the above direction of the FAA, the Assistant Director and PIO, Directorate of New and Renewable Energy, Nagaland, Kohima, had furnished the above mentioned information to the Applicants (now Appellants) vide letter No.DNRE/RTI-4/2010(pt-II)/6334 dated 03-03-2016.

AND WHEREAS, the applicants (now appellants) had submitted a second appeal vide No. PGD-1/2015-16 dated 08-06-2016 to the Commission stating that the requisite information was not furnished to them even after the hearing held by the FAA.

AND WHEREAS, the Commission has decided to hear the Appeal, giving opportunity to all the parties on **29<sup>th</sup> July, 2016 (Friday) at 2:00 P.M** in the **Hearing Room of the Nagaland Information Commission, Old Secretariat Complex, Kohima.**
