**Subject: Closing of appeal case.**

WHEREAS under Section 18 of the Right to Information Act, 2005, and in accordance to the Nagaland State Information Commission (Appeal Procedure) Rules, 2005, the Nagaland Information Commission had heard the complaint dated NIL submitted by Shri. Akaho Chophi, Land Owner, Rotomi Village, Zunheboto, Mobile: 9862043425 wherein the complainant stated that he did not receive any satisfactory information to his RTI application dated 31.01.2012.

AND WHEREAS the Commission had, after hearing both the parties, passed decision on the complaint on 19.09.2013;

AND WHEREAS in compliance to the decision of the Commission, the Office of the Deputy Commissioner, Zunheboto, Nagaland had, vide letter No. DCZ/RTI-1/2011-12/836 dated 24.09.2013 submitted to the Commission that after detailed enquiry, it was found that:-

1. There is no record of Land compensation been paid for the land occupied by 164 TA Naga Company at Akuhaito under Atoizu Sub-Division of Zunheboto district.
2. There is no record of amount paid/total area covered and no record details of beneficiary list available in the office.

AND WHEREAS the Commission had, vide its directive of even No. dated 08.11.2013 directed the Secretary & First Appellate Authority, Land Revenue Department, Nagaland, Kohima and the Deputy Commissioner, Office of the Deputy Commissioner, Zunheboto, Nagaland directed that since there was no action taken till date with regard to **Para – I** of the decision of the Commission dated 19.09.2013, the directives given by the Commission in its decision dated 19.09.2013 be taken up positively within **22.11.2013**, and with a copy to this Commission.

AND WHEREAS in compliance to the directive of the Commission, the Under Secretary & PIO, Land Revenue Department, Nagaland, Kohima had, vide letter No. LR/7-15/RTI/2005 (Pt-II)/160 dated 13.11.2013 forwarded a Statement of the Secretary & First Appellate Authority, Land Revenue Department, Nagaland, Kohima declaring that no proposal for donation/acquisition of land/ land compensation for land occupied by 164 TA Naga Company at Akuhaito under Atoizu Sub-Division of Zunheboto district has been processed through the Department, and therefore, no such records or documents on the subject are available in the office of the Land Revenue Department, Nagaland, Kohima.

AND WHEREAS, the Commission had accepted the submissions of the Secretary & First Appellate Authority, Land Revenue Department, Nagaland, Kohima and the Office of the Deputy Commissioner, Zunheboto, Nagaland;
