WHEREAS under Section 18 of the Right to Information Act, 2005, the Commission had on 02.02.2015, received a complaint dated 27.01.2015 from an applicant, Shri. Rakesh Garg, Advocate, SCF 26, New Grain Market, Dirba Mandi – 148035, District Sangrur, Punjab, stating that there was no reply or information till date from the Information Officer-cum-Regional Transport Authority, Mokokchung, Nagaland to his RTI application dated 18.12.2014.

AND WHEREAS, the above applicant had earlier filed an RTI application dated 18.12.2014 addressed to the Information Officer-cum-Regional Transport Authority, Mokokchung, Nagaland alongwith the prescribed application fee of Rs. 10/- (Rupees ten only) paid vide IPO No. 27F 408876 dated 18.12.2014, requesting for confirmation of driving licence No. 8248/TV/MKG/10 dated 20.01.2010 valid upto 19.01.2016 issued to Shri. Bhajan Singh, S/o Jangir Singh for driving heavy transport vehicle, which the above applicant had stated that the information was required to be submitted in the Court. A photocopy of the driving licence No. 8248/TV/MKG/10 dated 20.01.2010 Shri. Bhajan Singh, S/o Jangir Singh was also enclosed.

AND WHEREAS, the applicant had sent the RTI application dated 18.12.2014 to the Information Officer-cum-Regional Transport Authority, Mokokchung, Nagaland by Speed Post No. RP 371712930 IN dated 18.12.2014 and had also enclosed a photocopy of the receipt of the aforementioned Speed Post.

AND WHEREAS, since the applicant did not get any information to his RTI application dated 18.12.2014 even after expiry of the stipulated time period of 30 days, he had submitted a complaint dated 27.01.2015 before this Commission.

AND WHEREAS, the Commission has decided to hear the complaint, giving opportunity to the parties, on **7<sup>th</sup> April, 2015 (Tuesday) at 12:00 PM** in the **Hearing Room of the Nagaland Information Commission, Old Secretariat Complex, Kohima.**
