WHEREAS under Section 18 of the Right to Information Act, 2005, and in accordance to the Nagaland State Information Commission (Appeal Procedure) Rules, 2005, the Nagaland Information Commission had, on **12th May, 2015 (Tuesday) at 2:30 PM.** heard the complaint for the **third time**, which was submitted by an applicant, Shri. Yanrenthung Kikon, UDA, Judicial Section, Deputy Commissioner's Office, Wokha, Nagaland, Mobile No. 8974146911 against the non-furnishing of information by the PIO, Office of the Irrigation & Flood Control, Wokha, Nagaland to his RTI application dated 11.08.2014 within the specified time limit under RTI Act, 2005.
