

### Subject: Notice for hearing on 19th March, 2012 (Monday) at 01:00 PM.

WHEREAS under Section 19 of the Right to Information Act, 2005, this Commission have received a second appeal dated 23.01.2012 from Shri. Theruovilie Mepfuo, L- Khel, Kohima Village, Kohima, Mobile No. 9862117053/9862561639, against the decision order dated 15.12.2011 passed by the Secretary & First Appellate Authority, Land Revenue Department, Nagaland, Kohima with regard to his first appeal dated 16.10.2011;

AND WHEREAS the appellant contends that the Secretary & First Appellate Authority, Land Revenue Department, Nagaland, Kohima had passed an impugned order which was irrelevant and do not answer the queries made by the appellant;

AND WHEREAS the appellant had filed the first appeal dated 16.10.2011 to the Secretary & First Appellate Authority, Land Revenue Department, Nagaland, Kohima against the in-complete and irrelevant response of the APIO, Land Revenue Department, Nagaland, Kohima vide No. LR/7-15/RTI/2005(Pt) dated 27.09.2011 to the applicant's RTI request dated 23.08.2011, seeking information on 2 (two) points, namely:-

- a) Whether the Assam Land & Revenue Regulation Act, 1886 is in force in Dimapur area of Nagaland? If yes, by which Notification the regulation has been made applicable? and;
- b) If in force, to furnish a copy of the Notification issued under Section 2 of the Regulation 1 of 1886.

AND WHEREAS the Commission has decided to hear the appeal, giving opportunity to the parties on 19<sup>th</sup> March, 2012 (Monday) at 01:00 PM in the Hearing Room of the Nagaland Information Commission, Old Secretariat Complex, Kohima.
