

# Subject: Notice for hearing on 26<sup>th</sup> March, 2012 (Monday) at 01:00 PM.

WHEREAS under Section 19(3) of the Right to Information Act, 2005, the Nagaland Information Commission have received a second appeal dated 08.02.2012 from an appellant, Mr. R. Paphino, Chairman, Vigilance Cell, NPCC, Congress Bhavan, Kohima, against non-response or decision from the Director & First Appellate Authority, Directorate of School Education, Nagaland, Kohima on his first appeal dated 21.10.2011;

AND WHEREAS the appellant had filed the first appeal dated 21.10.2011 to the Director & First Appellate Authority, Directorate of School Education, Nagaland, Kohima against the non-response of the PIO, Directorate of School Education, Nagaland, Kohima to the applicant's RTI request dated 19.09.2011, seeking information relating to Sarva Shishak Abhiyan (SSA) program implementation and expenditures for the year 2008-09, 2009-10 & 2010-11 on the following three (3) queries, namely:-

- i. Total amount allocated to all the schools throughout Nagaland (school-wise)
- ii. Nature of works against fund sanctions (school-wise)
- iii. Actual Payee Receipts against each sanction (school-wise)

AND WHEREAS the appellant had clarified that information at Sl. Nos. (i) and (ii) above were received earlier from the Directorate of School Education, Nagaland, Kohima through a separate RTI request dated 03.05.2011, the appellant now prefers second appeal only on query No. (iii) above i.e. "Actual Payee Receipts against each sanction (schoolwise)";

AND WHEREAS the Nagaland Information Commission has decided to hear the appeal, giving opportunity to the parties on <u>26<sup>th</sup> March, 2012 (Monday) at 01:00 PM</u> in the **Hearing Room of the Nagaland Information Commission**, Old Secretariat Complex, Kohima.
