WHEREAS under Section 19(3) of the Right to Information Act, 2005, the Nagaland Information Commission have received a second appeal dated 15.03.2012 from an appellant, Mr. Pagai Ndong, C/o Hiareurangbe, Office of the Deputy Commissioner, Peren, Nagaland, Mobile No. 9856461322, against unsatisfactory response from the Deputy Commissioner & First Appellate Authority, Peren, Nagaland, on his first appeal dated 10.02.2012;

AND WHEREAS the appellant had filed the first appeal dated 10.02.2012 to the Deputy Commissioner & First Appellate Authority, Peren, Nagaland, against the unsatisfactory response of the PIO, Office of the Deputy Commissioner, Peren, Nagaland, to the applicant's RTI request dated 16.12.2011, seeking information relating to the details of amount sanctioned by the Ministry of Home Affairs, Government of India under the National Calamity Contingency Fund (NCCF) for the year 2009-2012 for Peren district;

AND WHEREAS the appellant had stated that consequent upon his first appeal on 10.02.2012, information was provided through the EAC, Office of the Deputy Commissioner, Peren, Nagaland which was unsatisfactory on the following grounds:-

- i. Information provided was incorrect, incomplete and misleading;
- ii. The dates of the letter No. DEV/RTI-2/2006-07/775 dated 06.02.2012 on the body of the information furnished was misleading;

AND WHEREAS the Nagaland Information Commission has decided to hear the appeal, giving opportunity to the parties on **27<sup>th</sup> April, 2012 (Friday) at 01:00 PM** in the **Hearing Room of the Nagaland Information Commission, Old Secretariat Complex, Kohima.**
