**Subject: Notice for hearing on 28<sup>th</sup> September, 2012 (Friday) at 01:00 PM.**

WHEREAS under Section 19 of the Right to Information Act, 2005, the Nagaland Information Commission had heard the second appeal dated 15.03.2012 for the third time on 25.07.2012 at 1:00 PM in the Hearing Room of the Nagaland Information Commission, wherein the appellant, Mr. Pagai Ndong, C/o Hiareurangbe, Office of the Deputy Commissioner, Peren, Nagaland, Mobile No. 9856461322 and the respondents i.e. Shri. Lungheising, Addl. Deputy Commissioner & PIO, Office of the Deputy Commissioner, Peren, Nagaland and Ms. Zuring Madeliang, EAC & APIO, Nsong, Office of the Deputy Commissioner, Peren, Nagaland were present.

AND WHEREAS basing on the submission of the ADC & PIO, Peren and EAC, Peren before the Commission during the hearing on 25.07.2012, that **they had never received** a copy of the sanction order from the Home Department as well as break up of Rs.74.74 lakhs into the four sectors, except that the only amount received by the DC Office, Peren was Rs. 25 lakhs (Rs. 20 lakhs for calamity relief and Rs. 5 lakhs for emergency relief funds of the DC, Peren), the Commission in its Decision Order dated 25.07.2012 directed the DC Office, Peren to file an Affidavit accordingly.

AND WHEREAS in compliance to the Commission's Decision Order dated 25.07.2012, the Deputy Commissioner & FAA, DC Office, Peren who is also the Head of the District Administration had submitted the Affidavit dated 08.08.2012 before the Commission stating that the DC Office, Peren had received the Sanction Order vide No. RR/NATC/1/2007-2008(Pt) dated 23.10.2010 granting an amount of Rs. 20.00 lakhs as **Calamity Relief Fund under NCCF** for the year 2009-10 (at Sl. No. 4 of the Affidavit) and the same amount received in 2010 (at Sl. No. 11 of the Affidavit). Also, the DC Office, Peren had received the Order for release of **Drought Relief under NCCF/NDRF** for the year 2009-10 vide Order No. NATC/5/2007-2008(Pt) dated Kohima the 24.10.2010 granting an amount of Rs. 74,74,775.00 (at Sl. No. 5 of the Affidavit) and the same amount received in 2011 (at Sl. Nos. 10 & 11 of the Affidavit).

AND WHEREAS on the serious anomalies pointed out in the above affidavit, the Commission takes a serious view that the ADC & PIO and EAC, Peren had **misled the Commission** by giving misleading and false information before the Commission during the hearing on 25.07.2012;

AND WHEREAS the Nagaland Information Commission has decided to hear the appeal, giving opportunity to the parties on **28<sup>th</sup> September, 2012 (Friday) at 01:00 PM** in the **Hearing Room of the Nagaland Information Commission, Old Secretariat Complex, Kohima.**
