WHEREAS under Section 19 of the Right to Information Act, 2005, the Nagaland Information Commission have received a second appeal vide letter No. LCS/SIC/11-12 dated 19.03.2012 from an appellant, Mr. Khekuto Tuccu, President, Life Consumer Society & RTI, Behind Town Hall, OB-47, Super Market Complex, Dimapur District, Nagaland – 797112, Contact No. 9615087958, against the un-satisfactory response of the CEO & First Appellate Authority, Dimapur Municipal Council, Dimapur, Nagaland vide letter No. DMC/RTI/1/2011-12/2667 dated 28.02.2012 to his first appeal dated 05.01.2012;

AND WHEREAS the applicant (now appellant) had submitted his first appeal vide letter No. LCS/RTI/DMC/11-12/13 dated 05.01.2012 to the CEO & First Appellate Authority, Dimapur Municipal Council, Nagaland, against the un-satisfactory response of the PIO, Dimapur Municipal Council, Dimapur, Nagaland, vide letter No. DMC/RTI/2011-12 dated 20.12.2011 to the applicant's RTI request No. RTI/DMC/04/2011-12 dated 21.11.2011, seeking information on 11 (eleven) queries;

AND WHEREAS the CEO & First Appellate Authority, Dimapur Municipal Council, Nagaland vide letter No. DMC/RTI/1/2011-12/2667 dated 28.02.2012 had simply forwarded the letter of the PIO, Dimapur Municipal Council, Nagaland, which was written to the CEO & FAA vide letter No. DMC/RTI/2011-12/2663 dated 27.02.2012 replying to some of the queries;

AND WHEREAS the Nagaland Information Commission had vide letter No. NIC/Appeal-21/2011-12/137 dated 30.03.2012 advised the appellant to clarify more clearly those points which according to the appellant are misleading replies, even though the PIO, Dimapur Municipal Council, Dimapur had furnished the replies vide letter No. DMC/RTI/2011-12 dated 20.12.2011 and also the CEO & FAA, Dimapur Municipal Council, Dimapur vide her letter No. DMC/RTI/1/2-11-12/2667 dated 28.02.2012 has clarified the first appeal vide No. LCS/RTI/DMC/11-12/13 dated 05.01.2012;

AND WHEREAS the appellant vide letter No. LCS & RTI/12-13/12 dated 05.06.2012 had clarified more specifically the grounds for furnishing misleading replies by the PIO and the CEO & FAA, Dimapur Municipal Council, Dimapur;

AND WHEREAS the Nagaland Information Commission has decided to hear the appeal, giving opportunity to the parties on **7<sup>th</sup> August, 2012 (Tuesday) 01:00 PM** in the **Hearing Room of the Nagaland Information Commission, Old Secretariat Complex, Kohima.**
